

## Balancing the Scales: Justice Reform for Women

Sunday, April 14, 2019
2 to 3:30 pm
CitySpace, Downtown Mall, Charlottesville



Injustice in the justice system is finally coming to light, especially as it disproportionately affects primarily African American and Latino men. But women in conflict with the law remained in the shadows until the *Legal Aid Justice Center in Charlottesville* revealed the inadequate and sometimes deadly medical care for women at the Fluvanna Correctional Center for Women.



The LWV CVA *Sunday Seminar* on April 14 will feature Shannon Ellis who joined the Legal Aid Justice Center in January 2017. Her work focuses on providing civil advocacy for vulnerable court-involved or incarcerated individuals. Before joining LAJC, Shannon practiced family law in Charlottesville and provided pro bono representation for LAJC's Special Immigrant Juvenile project. Shannon earned her bachelor's degree and law degree from the University of Virginia. Shannon will talk about the women at FCCW whose sometimes tragic experiences stoked a successful lawsuit against the State of Virginia.

Kim Rolla joined Legal Aid Justice Center as the Lewis F. Powell fellow in 2013, originally focusing on housing law, providing both individual legal representation and legal support to tenant organizations. In 2017, Kim transitioned to the Civil Rights and Racial Justice Program, and now develops campaigns to combat the criminalization of the poor, people of color, and far too many Virginians. Kim earned a B.A. from the College of William and Mary and law degree from the University of Virginia, and received the Herbert Kramer/Herbert Bangel Community Service Award.

#### International Relations / Federal Government Committee News

March 13 brought the members of the International Relations/Federal Government Committee to **Molly O'Brien's** welcoming home. **Marge Cox** and **Lois Sandy** presented reports and led discussion.

Marge explained the long and complicated dispute between India and Pakistan. They have fought three wars each claiming the state of Jammu and Kashmir. India's claims are based on an instrument of secession signed in 1947, while Pakistan's are founded on its majority Muslim population. At the same time, China claims the Shaksam Valley and Aksai Chin, which are also in the region. Pakistan is currently trying to crack down on terrorist activity sponsored by India. Some organizations have reported the deaths of several thousand Kashmiri civilians by Indian Armed Forces from 1990 to 1999, and the raping of thousands of women between the ages of 7-70.

Lois continued her report on Saudi Arabia's crown prince Mohamed Bin Salmon (MBS) from our September 12 meeting. In December MBS was accused of plotting the horrific murder of Jamal Khasshoggi, a journalist who had been highly critical of him. President Trump announced he's primarily concerned with America First and will not jeopardize millions of dollars and confront MBS and that the administration is continuing its own investigation into this matter. In contrast, the U.S. Senate passed a resolution blaming Khasshoggi's death on MBS and also one to end US military assistance for the Saudi-led war in Yemen.

Meanwhile Jared Kushner has met with both MBS and Erdogan of Turkey on his mission to bring peace to the Middle East. Erdogen has been critical of Israel's treatment of the Palestinians. MBS has talked with President Xi Jinping of China, but no mention was made of up to one million Muslim Uighurs being held in internment camps in China despite the ruling family's claim to be the defender of all Muslims. In spite of his tacit support of gross human rights violations, the Saudi Prince attempts to rebuild his reputation by releasing thousands of Indians and Pakistanis from Saudi Arabian prisons as well as making investments in both countries.
