International Relations / Federal Government Committee News

On May 8 the International Relations/Federal Government Committee met in the home of Kit Murphy McNally where we heard and enthusiastically discussed Kit's report on the Federalist Society as well as Lois Sandy's presentation on Ruth Bader Ginsburg.

An article by David Montgomery called "Conquerors of the Court" was the source of Kit's report. The Federalist Society was founded in 1982 by a group of conservative law students who felt strongly that it should allow for the vital exchange of ideas and not endorse one particulate party or candidate. They believed the Constitution should be interpreted exactly as the framers intended. In 1986 the Society brought together conservatives and libertarians and melded their philosophies, yet they still represent a minority of law students today. The **Federalist Society** has been influential in the Trump administration, hand-selecting Supreme Court Justice Neil Gorsuch and Brett Kavanaugh and recruiting a slate of conservative judges to fill vacancies throughout the federal judiciary. Now liberals have begun to use some of their tactics to promote a progressive agenda.

Lois's report sparked a lively discussion of women's rights and their evolution during the past eight decades, and the hard work and fervor that led to Ruth Bader Ginsburg's success in defending them. Lois emphasized the symbiotic relationship that Ruth and her husband enjoyed, which was an important factor in their combined accomplishments. The members also discussed the problems of incapacity with an aging Supreme Court and alternatives to lifetime appointments.

Justice Reform Examines Prosecutorial Discretion

How prosecutorial discretion affects women in conflict with the law in Charlottesville/Albemarle and surrounding counties is now a central focus of the LWV CVA Justice Reform Committee. Committee members are meeting with commonwealth attorneys while learning about programs available to women as an alternative to incarceration and as re-entry supportive services. At the May meeting, Dorothy Tompkins, MD, founder of Georgia's Healing House, discussed this relatively new option for women who have been involved with the justice system and are recovering from addiction. While learning firsthand about programs and services that benefit at-risk women in the local area, the Committee is considering what legislation, alternative practices or restorative programs elsewhere could potentially become local options to divert more women from prosecution or incarceration. The committee meets the last Tuesday of every month from 11:30 am -1:00 pm at the Center for Nonprofit Excellence. Contact Kit Murphy McNally for more information: murphymcnally@gmail.com
