Then LWV CVA vice-president, Rosalie Simari, leads the Program Planning meeting in 2018 on national and local Programs. Following the two-year cycle, program planning this December will again focus on national and local programs.

What is "Program Planning"? Program Planning happens annually at the local League level. It is the time when we consider the positions taken by our League on the local and state or national levels. Our positions give the League a voice and are the result of an established process: the LWV takes action on an issue or advocates for a cause when there is an existing League position that supports the issue or speaks to the cause. Without a position, League action/advocacy cannot be taken. This is what your League of Women Voters is all about and Program Planning is your opportunity to weigh in.

For 2019, we will study **Local** and **National League positions** in preparation for our May 2020 LWV CVA Annual Meeting as well as the June LWV US convention, this year in Washington, DC. Do we wish to retain current positions, to act on them, and/or to begin new studies with the goal of establishing consensus and positions for action on other issues? As part of this review, we will hear from committee members who will be suggesting updating current local program "Action" statements. Our recommendations from this meeting will be presented to our members for approval at the Annual Meeting in May.

In addition, the LWV CVA Natural Resources Committee has submitted a proposal to update our local Natural Resources position with a statement on Climate Change. Besides these Child Care and Natural Resources "Action" proposed revisions, there will be presentations on suggested revisions to Education, Government, Health Services in Public Schools, and Health and Family Life Education. International Relations / Federal Government Committee News by Gerry Kruger

Once again **Molly O'Brien** graciously hosted the International Relations/Federal Government Committee on November 13th. **Kathy Suddeth's** report was centered on the history of the bellicose relationship between Kashmir and India, and the present situation in the area since Indian Prime Minister Narendra Modi's government has stripped away the rights of Kashmiris and imposed harsh restrictions. Modi belongs to an extreme rightwing Hindu group, and most Indians support his government.

Kashmir became a territory after the August 5, 2019 crackdown and lost status to the formal state of India. Businesses, schools, and elections were all affected. Since the crackdown, violence and insurgence has increased, and the whole economic structure of Kashmir has been destroyed. Pleas from Pakistan's leader for other countries to take action have been unsuccessful, most likely because of India's superior economic power.

Next **Carolyn Fitzpatrick** gave a thought-provoking summary of an *Economist* article called "The Generation Game." She presented the stark differences between the family lives of boomers and millennials.

For example, millennials are having fewer children. Rather than walking or biking, their children are driven everywhere. Most are engaged in screen time for the majority of their days, and are increasingly addicted to the Internet.

A huge majority of today's children come from urban households and one-parent families. Marriages are at an all-time low. Divorces are at an all-time high, and single-parent homes are generally poorer. Most women -- both married and single-- work. The United States is one of the few developed countries that does not provide federal maternity leave.

Children born between 1995 and 2012 are exposed to an enormous amount of data that can never be retracted. They spend most of their time indoors with adults rather than siblings or friends. This may be partly because they have fewer safe places such as schools and churches, and parents are afraid of what will happen if they spend time away from home with friends. Surveys show that the happiness gap between children of the affluent and the working class is widening. The affluent are more likely to be enrolled in sports, camps, and organized activities which require fees and transportation.

On the positive side, child mortality rates are dropping, fewer children go hungry, and more finish secondary school and go on to higher education.

Study Questions

- 1. Are standards for child care licensing thorough enough?
- 2. Is enforcement of child care licensing adequate?
- 3. Is training and education for child care workers adequate?
- 4. When CPS (Child Protective Services) investigates an incident at a child care center, should families of the children involved in the investigation be given information regarding the investigation?

Current "Action" Statement in LWV CVA 2019-20 Handbook for Members under "Local Program: Positioned for Action"

Child Care:

Action: Support of community-based efforts to improve the quality and affordability and accessibility to child care in the Thomas Jefferson Planning District. To advocate for 1) Increased business and local government support for child care and 2) improved information for parents and the community at large regarding available child care and performance of child care providers. [2001]

Proposed addition to the above Action statement based on the Study findings:

Support efforts to improve child care licensing standards, with a goal of having them be more in line with the "Caring for Our Children Basics: Health and Safety foundations for Early Care and Education" from the Administration for Children and Families, U.S. Department of Health and Human Services.

Support improvement of licensing enforcement regulations.

Support and encourage competent personnel in the Virginia Department of Social Services Child Care Licensing Division.

Support "Virginia Quality", the state's quality rating and improvement system, which includes training and mentoring, and encourage local centers to participate in "Virginia Quality".

Support improved and increased training and education for local child care workers.

Support government transparency, whenever possible, while still protecting the confidentiality of children, in Child Protective Services (CPS) cases that occur in child care centers, so that parents have representation and access to information about cases involving their children.

Acknowledge the child care crisis of a lack of quality, affordable child care in our region. Recognize that cost is a major contributing factor to the crisis and encourage more study into alleviating cost, probably through government subsidies. [2019]

Climate Change:

Action: Adhering to the position of the LWVUS related to combating climate change, we support inclusion of goals and policies that are consistent with the best available climate science in the plans and decisions adopted by our local governments and the activities of our communities. [See LWVUS Position on Climate Change below.]

Energy:

Current version

Action: Support for environmentally sound policies and activities that promote efficient use and conservation of energy and the use of renewable energy sources.

Updated version

Action: Support for environmentally sound policies and activities that promote efficient use and conservation of energy, the use of renewable energy sources, *and the reduction of greenhouse gases*.

Water:

Current version

Action: Support of policies and procedures which promote long-range planning and conservation of water resources through water conservation and watershed management of ground and surface waters, specifically: (1) develop conservation programs that include drought management as a key element in water supply planning, (2) reduce water usage by pricing and water-saving plumbing codes, (3) require users of ground water supplies to meet or exceed the standards of the State Department of Health, and (4) support septic system regulations that protect groundwater. Support for policies that protect surface water, ground water, and drinking water from contamination. Continued studying and monitoring of both ground and surface water issues and the implementation of water management plans, and advocating where appropriate.

Updated version

Action: Support of policies and procedures which promote long-range planning and conservation of water resources through water conservation and watershed management of ground and surface waters, specifically: (1) develop conservation programs that include drought management as a key element in water supply planning, (2) reduce water usage by pricing and water-saving plumbing codes, (3) require users of ground water supplies to meet or exceed the standards of the State Department of Health, and (4) support septic system regulations that protect groundwater. Support for policies *and infrastructure* that protect the *quality and quantity of* surface water, ground water, and drinking water. *Support for policies that manage storm water runoff to control erosion, silting, and transport of pollutants.* Continued studying and monitoring of both ground and surface water issues and the implementation of water management plans, and advocating where appropriate.

LWVUS Position on Climate Change (adopted January 2019)

Position In Brief: The League is calling for prompt action to cut this country's GHG emissions, invest in a clean energy economy, and help the world's poorest countries tackle the challenges of climate change. The League believes that climate change is a serious threat facing our nation and planet. The League believes that an international approach to combating climate change — including through energy conservation, air pollution controls, building resilience, and promotion of renewable resources — is necessary to protect public health and defend the overall integrity of the global ecosystem. The League supports climate goals and policies that are consistent with the best available climate science and that will ensure a stable climate system for future generations. Individuals, communities, and governments must continue to address this issue, while considering the ramifications of their decisions, at all levels — local, state, regional, national, and global.

Revisions discussed at the FG/IR meeting Nov 13, 2019 at Molly O'Brien's related to the Government statement in of current "Action" statement the 2019-2020 membership book and website lwv-cva.org

Current:

Government: Action: Support of long-range planning; sharing and/or consolidating resources, services, and structures; and increased cooperation between Charlottesville Area and the University of Virginia. Support of a fair and flexible tax system necessary for responsive government, using the following criteria in evaluating taxation proposals and/or reform measures: equity, including the ability to pay and benefits received; consistency with social and economic goals of the community and the LWV; efficiency of administration, including computation, payment and collection methods, and public understanding; adequacy of revenue, including ability to adjust to changes in economic conditions. Support for increasing the number of magisterial districts in the County to an odd number (7 or 9). Support for a mix of urban and rural residents in each district, taking into account natural geographic boundaries and communities. Encourage the Board of Supervisors to appoint a task force to study the feasibility of seeking a charter for the County. Support of the Sustainability Accords, particularly of the section on Government Goal: Governmental decisions are made in an environment that promotes widespread, informed, and civil public participation. [1990]

Government

Action:

Support of long-range planning; consolidating resources, services, and structures; and increased cooperation between Charlottesville Area and the City of Charlottesville and the University of Virginia.

Support of a fair and flexible tax system necessary for responsive government.

Support of the Sustainability Accords, particularly of the section on governmental decisions made in an environment that promotes widespread, informed, and civil public participation.

Support a fair election system that strictly follows election laws and the nonpartisan administration of election rules and procedures for electing public officials for federal, state, or local governments.

Support public education on vulnerabilities in our election system and the potential for disruptive disinformation campaigns, and work with others who participate in making our voting systems accurate.

Support for local and state government supporting fair state redistricting laws.

Support transparency, security, and accountability in the certification and reporting of election results, including post-election audits and risk-limiting audits.

Support citizens right to vote as outlined in the U.S. and Virginia Constitutions and local Dept of Elections monitoring any instances of voter suppression.

Support dissemination of voting information by public announcements, notice of registration deadlines, forums, and other voter services.

Support for Virginia constitutional amendment resolution passage of SJ306. (Women's Rights and Virginia Law.)

Follow relevant events and general conditions abroad to help inform current League actions and articulation of future ones. [2019]

Current Action Statement as found in LWV CVA 2019-20 Handbook (page 16):

Health and Family Life Education and Health Services in Area Public Schools:

Action: Support of the following health services and programs: a dedicated health facility which conforms to state and national guidelines; a full time health professional for each school health facility; school advisory boards which include health professionals, parents, and community members; a qualified and trained director of school health programs; and health and family life education in our area schools which includes: regular periodic review of curriculum to ensure updating with new information or materials and to meet needs that are identified, more age-appropriate comprehensive sexuality education, continued training of teachers in health and family life education of students and teacher training, identifying additional resource materials and making them available to students, parents and teachers, increasing community and family understanding of and involvement in health and family life education. (2013)

Suggestion Revision(s):

Health and Family Life Education and Health Services in Area Public Schools Action: Support of the following health services and programs: a dedicated health facility which conforms to state and national guidelines; a full time health professional for each school health facility; <u>a qualified mental health professional for each school</u>; school advisory boards which include health professionals, parents and community members, a qualified and trained director of school <u>physical and mental health</u> programs; and health and family life education in our area schools which includes: regular periodic review of curriculum to ensure updating with new information or materials and meeting needs that are identified, more age-appropriate comprehensive sexuality education, continued training of teachers in <u>physical and mental health</u> and family life curricula and issues; use of experts to participate in <u>physical and mental health</u> and family life education of students and teacher training, identifying additional resource materials and making them available to students, parents, and teachers, increasing community and family understanding of <u>physical and mental</u> health and family life education.

Education

Action:

Support of equal access to a quality public elementary and secondary educational system from pre-kindergarten through high school with adequate funding, competent personnel, well-maintained facilities, and adequate resources and supplies.

Support of specified statements to assure quality education, particularly addressing the needs of diverse student populations in the Charlottesville Area school systems, including the City of Charlottesville, Albemarle County, and Fluvanna County.

Support for local policies that promote learning by recognizing that the basic needs of all children include health care and adequate nutrition.

Support for local policies that promote learning by recognizing the basic needs of all children include mental and physical health and adequate nutrition. (2019)

Support and funding for pre-kindergarten programs and full-day kindergarten programs for all students.

Support for curriculum and programs that prepare students for a 21st century workforce by providing emphasis on scientific, technological, engineering, and mathematical skills.

Support for curriculum and programs that prepare students for a 21st century workforce by providing emphasis on scientific, technological, engineering, and mathematical skills that correlate with critical thinking, and the cyber age.

Support for increase in internet access and cyber education. This includes teaching about artificial intelligence and how to be discriminating readers and listeners in dealing with media as early as first grade. Support all aspects of community education, including teaching about gun safety, violence prevention, and protection. (2019)

Support of all aspects of community education. Support of specific ways to attract and retain quality classroom teachers and to encourage excellence in teaching. Continued monitoring of local school systems, with special emphasis on expenditures and funding sources, education and extracurricular programs, salaries and responsibilities, and citizen involvement. Special attention to potential major changes in local school systems. [2013]
