



There is proposed legislation on the removal of monuments that will affect how Charlottesville and Albemarle County deal with this difficult issue.

STANDING FOR GUN SAFETY IN MEMORY OF GREAT LOSS:

On the 7th anniversary of the massacre at Sandy Hook December 14, members of the LWV joined others advocating for gun safety at a vigil on the Charlottesville Downtown Mall in remembrance of Sandy Hook, the children's caregivers, their parents and families, and a grieving nation. Gathered in front of the mall Christmas tree on that sunny, but chilly Saturday, advocates for gun safety called out the sites of mass gun violence noted by a solemn gong: Jersey City, Virginia Beach, El Paso, Dayton, Odessa and Midland, The Tree of Life Synagogue, Thousand Oaks, Marjory Stoneman Douglas School, Sutherland, Las Vegas, Mother Emmanuel Church, Orlando, Aurora, Virginia Tech, Columbine and Sandy Hook. Again the gong sounded solemnly as one by one those at the vigil called out the name of a child . . . and the shooter who died 7 years ago through gun violence at an elementary school.

LWV CVA Natural Resources Committee Meeting Report by Muriel Grim

The Natural Resources Committee met at University Village on December 5, 2019. We discussed preparations for our upcoming February Sunday Seminar that will be about our response to climate change. At the seminar a panel will answer questions that were formulated by the committee and then there will be questions from the audience. The NRC's questions will be decided at our January meeting and will be given to the panelists before the February seminar so that they will be able to carefully prepare their answers. Several possible panelists were considered; they will be contacted over the next few weeks. So that there will be a wide range of expertise on the panel we plan to have panelists representing local governments and the university and NGOs that are concerned with climate change.

There was discussion about things that are being done by citizens and government to reduce greenhouse gases. We will ask the panelists to speak about efforts that will produce the most effect and how we can personally make lifestyle changes, vote, advocate, and donate time and money in ways that will be most effective.

This led to discussion about the importance of Leaguers attending meetings as observers so that they can report to us and show those holding the meeting that we have an interest. When doing this it would be helpful if we all wear buttons or clothing that identify us as members of the League. Related to this Linda Goodling said she would try to attend the following day's UVA Board of Visitors meeting where a sustainability goals resolution would be considered. (Follow-up: at the meeting the BOV approved the resolution that set sustainability goals for the university which include carbon neutrality by 2030 and being free of fossil fuels by 2050.)

We briefly discussed the Champion Brewing Company request to operate a "farm brewery" on the banks of the South Fork Rivanna Reservoir, on Earlysville Road. We decided to get more information as quickly as possible.

In order to finalize plans for the February Seminar at our January meeting, we set the next NRC meeting for January 9, 2020, at 1 pm.

Equal Rights Amendment Update by Megan Tracy

Our deepest thanks to all of you who have worked so long and hard to support ratification of the Equal Rights Amendment in Virginia! We are almost there. State Senator, Jennifer McClellan (SD-9) and Sen. Mamie Locke (SD-2) have filed SJ 1 for the 2020 General Assembly. Chief Patron, Jennifer Carroll Foy (HD-2) has filed HJ 1 in the VA House. The LWV-VA is joining once again with *VAratifyERA* on January 8th to welcome legislators back on Opening Day of the General Assembly. *VAratifyERA* has a day of activities planned AND is arranging for a bus to leave from Charlottesville on the morning of the 8th. Other ERA dates to keep in mind: January 13th is the "tentative" date for the passage of SJ1 and HJ1 out of their respective chambers. January 20th is the "tentative" date for the final passage of HJ1 and SJ1. International Relations/Federal Government Committee Report by Gerry Kruger

The International Relations/Federal Government Committee met in Beth Alley's home on December 12 for our program and annual holiday luncheon in spite of Beth's being in New York due to a family medical emergency. Our members shared the hosting duties, with Rosalie Simari taking over the lion's share of hostess responsibility. A special surprise was the appearance of Flora Patterson who brought a smile to both old and new members. Even those who had never met her had heard how much she meant to our League during her many years in Charlottesville.

Marge Cox began by reporting on Russia's moves to control the Arctic region's northern sea route, which passes along the country's northern coast in the Arctic. Russia requires foreign military ships to give advance notice and obtain permission to use the passage. The new Russian rules require that foreign military ships take on board Russian pilots while sailing. Even if the foreign vessels meet all Russia's requirements, the Russian authorities still can reject their request for passage without explanation. In the event of an unsanctioned passage, the foreign vessels could be arrested and even destroyed.

The Arctic has a wealth of oil in the Arctic fields as well as natural gas and valuable minerals. Russia is not the only country that borders and claims the Arctic. It is under the jurisdiction of Canada, Norway, Russia, Denmark (via Greenland), Iceland, Sweden, Finland and the United States.

To prove Russia's dominance in the area, Putin launched Thunder 219 in October. At this time Russia tested its arsenal of missile launchers, aircraft, surface warships, and nuclear submarines. A Russian news release has also announced that Russia's claim to the Arctic has been proven by testing.

Proposed Program Update for Government

The LWV-VA Positions on Election Laws, Reapportionment and Redistricting attached are for reference only.

Action: Support of long-range planning; sharing and/or consolidating resources, services, and structures; and increased cooperation between Charlottesville Area and the University of Virginia.

Support of a fair and flexible tax system necessary for responsive government,

using the following criteria in evaluating taxation proposals and/or reform measures: equity, including the ability to pay and benefits received; consistency with social and economic goals of the community and the LWV; efficiency of administration, including computation, payment and collection methods, and public understanding; adequacy of revenue, including ability to adjust to changes in economic conditions. Support for increasing the number of magisterial districts in the County to an odd number (7 or 9). Support for a mix of urban and rural residents in each district, taking into account natural geographic boundaries and communities. Encourage the Board of Supervisors to appoint a task force to study the feasibility of seeking a charter for the County.

Support of the Sustainability Accords **(TJPD, 1998)** particularly of the section on Government Goal: **governmental decisions** made in an environment that promotes widespread, informed, and civil public participation. [1990]

Action: Adhering to the position of the LWV-VA relating to election laws,

LWV-CVA: Support public education on vulnerabilities in our local election system and the potential for disruptive disinformation campaigns or voter suppression, and work with others, such as local registrars, in making our voting systems accurate.

Support transparency, security, and accountability in local post-election audits and risk-limiting audits.

Support dissemination of local voting information by public announcements and offering nonpartisan candidate forums

Adhering to the LWV-VA position on reapportionment and redistricting, support local efforts to promote fair state redistricting laws. (2019)

From the LWV-VA Positions in Brief:

ELECTION LAWS

Position in Brief: The League of Women Voters of Virginia believes that democratic government depends on the informed and active participation of its citizens; that voting is a right and responsibility; and that election laws, regulations and administrative procedures should be uniformly designed and applied, and adequately funded to facilitate and increase voter participation throughout Virginia.

Specifically, the League supports measures to ensure the availability of voter registration and to encourage and facilitate increased voter participation in elections, including: absentee voting by mail and in- person without a reason; an adequate number of voting machines and trained election officers; the use of satellite voting; split shifts for election officers when needed; and measures that take advantage of technological advances such as online voter registration and the use of electronic poll books. The League also supports the shared funding of statewide registration and voting systems by the localities and the Commonwealth; providing adequate authority and resources to the Department of Elections (ELECT) and the State Board of Elections (SBE) for oversight and enforcement of laws and standards for registration and elections uniformly throughout the Commonwealth; and the use of secure electronic means to facilitate voter registration and absentee voting for Virginia's military and overseas voters. (2011, 2015)

REAPPORTIONMENT& REDISTRICTING

Position in Brief: Support for a decennial redistricting plan approved by the General Assembly, including establishment of a bipartisan commission to prepare a plan for legislative approval, and consideration of natural geographic boundaries, jurisdictional boundaries, communities of interest, and competitiveness in addition to the constitutional requirements.

The League of Women Voters of Virginia supports the establishment, in law, of a politically balanced and independent Reapportionment Commission for each decennial redistricting to prepare, with the Virginia Department of Legislative Services, a plan for submission to the legislature as specified by the Virginia

Action: Adhering to the position of the LWVUS related to combating climate change, we support inclusion of goals and policies that are consistent with the best available climate science in the plans and decisions adopted by our local governments and the activities of our communities. Energy:

Current version

Action: Support for environmentally sound policies and activities that promote efficient use and conservation of energy and the use of renewable energy sources.

<u>Updated version</u>

Action: Support for environmentally sound policies and activities that promote efficient use and conservation of energy, the use of renewable energy sources, *and the reduction of greenhouse gases*.

Water:

Current version

Action: Support of policies and procedures which promote long-range planning and conservation of water resources through water conservation and watershed management of ground and surface waters, specifically: (1) develop conservation programs that include drought management as a key element in water supply planning, (2) reduce water usage by pricing and water-saving plumbing codes, (3) require users of ground water supplies to meet or exceed the standards of the State Department of Health, and (4) support septic system regulations that protect groundwater. Support for policies that protect surface water, ground water, and drinking water from contamination. Continued studying and monitoring of both ground and surface water issues and the implementation of water management plans, and advocating where appropriate.

<u>Updated version</u>

Action: Support of policies and procedures which promote long-range planning and conservation of water resources through water conservation and watershed management of ground and surface waters, specifically: (1) develop conservation programs that include drought management as a key element in water supply planning, (2) reduce water usage by pricing and water-saving plumbing codes, (3) require users of ground water supplies to meet or exceed the standards of the State Department of Health, and (4) support septic system regulations that protect groundwater. Support for policies and infrastructure that protect the quality and quantity of surface water, ground water, and drinking water. Support for policies that manage storm water runoff to control erosion, silting, and transport of pollutants. Continued studying and monitoring of both ground and surface water issues and the implementation of water management plans, and advocating where appropriate.

LWVUS Position on Climate Change (adopted January 2019)

Position In Brief: The League is calling for prompt action to cut this country's GHG emissions, invest in a clean energy economy, and help the world's poorest countries tackle the challenges of climate change. The League believes that climate change is a serious threat facing our nation and planet. The League believes that an international approach to combating climate change — including through energy conservation, air pollution controls, building resilience, and promotion of renewable resources — is necessary to protect public health and defend the overall integrity of the global ecosystem. The League supports climate goals and policies that are consistent with the best available climate science and that will ensure a stable climate system for future generations. Individuals, communities, and governments must continue to address this issue, while considering the ramifications of their decisions, at all levels — local, state, regional, national, and global.
