Directions to The Center at Belvedere: The Center at Belvedere's address is 540 Belvedere Boulevard, Charlottesville, VA. 22901, just off East Rio Road near the Covenant Church and CATEC.

- a. **From Downtown**, once the Warner Parkway becomes E. Rio Rd., you pass CATEC on your left. Turn Right at the next intersection onto Belvedere Boulevard.
- b. **From 29** turn onto E. Rio Road head toward Downtown Charlottesville for 1.5 Miles. Turn Left onto Belvedere Boulevard. If you pass CATEC on your right, you have gone too far.

Upcoming Sunday Seminar, April 19

WOMEN vs. INCARCERATION: What About Justice?

Why are women the fastest growing population in our prisons while crime is decreasing? What can we do about it?

That's a question that will fire the discussion at the April19 *Sunday Seminar* hosted by the LWV CVA Justice Reform Committee. Neal S. Goodloe, Jr., Criminal Justice Coordinator/Planner for the Thomas Jefferson Area Community Criminal Justice Board, will have answers, issues, actions and problems to share from his extensive research and practice. He has implemented and advised application of *Evidence Based Decision Making* in Virginia, Wisconsin, South Carolina and Massachusetts. This data-based decision-making leads to "Evidence Based Practice" supporting informed jail population management; jail and prison reentry planning; and improved and expanded community correction practices. In other words, he has studied who is in jail and prison and evaluated practices that can reduce incarceration and capitalize on community alternatives. Considerable time will be allotted to questions from those attending following his presentation.

LWV CVA Natural Resources Committee Report on the February **16 Sunday Seminar** By Muriel Grim

To help answer the question "What are the most effective actions we can take, both as individuals and as members of the Central Virginia community, to confront climate change?" the Natural Resources Committee convened a panel of local experts whose work includes addressing that question. At the February 16 Sunday Seminar, "Hot Matters: Climate in Crisis — What actions should we take?" Cheryl Gomez, director of operations for University of Virginia Facilities Management, Susan Kruse, executive director of the Charlottesville Climate Collaborative, Kristel Riddervold, environmental sustainability manager for the City of Charlottesville, and Narissa Turner, policy and campaigns manager for Climate and Clean Energy for the Virginia Conservation Network, discussed the problem from their perspectives.

All four panelists agreed that the most effective way to reduce greenhouse gas (GHG) emissions was to have a goal and then create and stick to a plan to reach that goal. This approach is useful on both a personal level (for example, converting, over time, to very energy-efficient appliances) and an organizational level (for example, setting sustainability goals, as UVA has done).

The panelists described what was necessary to develop plans and achieve goals. First, a baseline (measuring current energy consumption or GHG emission levels) must be determined so that progress can be measured. Then one must determine ways to overcome any barriers. All panelists pointed to working in isolation as the biggest barrier. People should communicate and work together to identify problems, discuss solutions, lend support, and fix problems. Existing laws can also create barriers. Again, working together and, in some cases, persistently appealing to legislators and administrators can be most effective at breaking down barriers. It was noted that comments and positive feedback, especially from people who do not usually contact legislators and decision makers, do make a difference.

Finally, fighting climate change should be integrated into all community and personal decisions. It should not be considered an additional cost but rather a "strategic investment".

LWV CVA Natural Resources Committee: Report of the February 27th meetingBy Muriel Grim

Responding to a LWVUS request, the Committee created a list of natural resources related LWVUS Positions that the NRC used during the last two years in order to act at local levels.

We discussed the February 16th Climate Change seminar and both approved and added more seminar information to what will be posted on the LWVCVA website.

We also discussed *Public Access TV* and whom we should contact about recording League events for Public Access. Lisa Hilgartner will pursue this for the whole local League and will let the board know what is possible.

Sally Thomas attended the Board of Directors of the Albemarle County Service Authority (ACSA) meeting on February 20 and spoke in support of finishing the Ragged Mountain Reservoir pipeline sooner than 2035. However she reported that the Service Authority is doing a very good job of managing financial resources and because of financial limitations the time frame for completing the pipeline probably cannot be shortened. She also attended the Board of Directors of the Rivanna Solid Waste Authority (RSWA) meeting and reported about the difficulty of finding destinations for recyclables but that some new products are now being made.

Tom Olivier talked with the committee about the need to bring consideration of sustainability back into planning. Using the definition of sustainability as "meeting the needs of the present without compromising the ability of future generations to meet their own needs" we discussed the fact that any kind of growth cannot continue forever. We must make sure we don't extract more resources, especially those necessary for human life, from the environment than we allow to return to the environment. (An example would be potable water.) To address environmental degradation we should plan in ways that don't expect that everything can grow. We should consider the concept of a circular economy replacing economic "growth". Tom, representing *Advocates for a Sustainable Albemarle Population* (ASAP), intends to present a "local sustainability" proposal to our local governments.

Dear Pat and Charlottesville League,

I'm still hoping the C-ville League would like to become the 7th Virginia local League to have its name engraved on the Donor Wall of the Turning Point Suffragist Memorial (http://www.suffragist.memorial.org). Many of your members are familiar with the project, but so far I have not heard if you all might like to put together the \$1000 that is needed to reach that designation. A number of state and local Leagues from all over the country have stepped in; LWV-VA and LWVUS are also donors. The local Leagues who are supporting the memorial include Arlington, Fairfax, Loudoun, Montgomery County, Prince William, and Williamsburg. Often these Leagues have bundled individual gifts to make up the needed amount and sent in one check. This would be an alternative to taking it out of your local budget.

The deadline for being accepted for the Donor Wall is April 30, 2020, so if you are considering this, be sure to make the deadline. Construction on the memorial has begun on the site of the imprisonment of the Suffragists for picketing President Wilsons' White House in 2017. The garden style memorial, to include statues of Carrie Chapman Catt, Alice Paul, and Mary Church Terrell, will be dedicated on August 26, 2020, Women's Equality Day, in Occoquan Regional Park in southern Fairfax County.
