State & Local LWV Support COVID-19 Justice Coalition By Kit Murphy McNally, LWV CVA Justice Reform Committee Chair

In this time of COVID-19 in Virginia, the state League of Women Voters (LWV-VA) and Charlottesville Area League (LWV CVA) joined forces with more than 50 diverse organizations throughout the state seeking action to empty prisons and jails of all women and men who can be *safely sent home*.

The activist initiative, headed by the ACLU of Virginia, is open to any concerned organization or individual. Meeting online bi-weekly, organization representatives use their collective strategies, actions and power to influence state and local policy makers and justice systems.

In a special session of the General Assembly in late April, Governor Northam won approval for the early release of more than 2000 eligible inmates in Virginia. However, by mid-May fewer than 250 had gone home. There are counter forces to early release from within the system and in some communities, both for those previously eligible and those who could be.

However, some local jurisdictions were already taking action by April. In Charlottesville, Commonwealth Attorney Joe Platania reported, "Prosecutors in the City of Charlottesville and the County of Albemarle, along with judges, court clerks, defense attorneys, law enforcement partners, and the superintendent of the local jail, have undertaken aggressive and proactive measures to release 113 individuals from custody, reducing our jail population from 421 to 308 in under four weeks." It's a start.

Beginning in the 1970's a "tough on crime "edict came down from the Federal Government and launched the surge of mass incarceration for great and small infractions. Increasingly people of color, diverse origins. . . and women filled the jails and prisons of the United States in numbers exceeding the rest of the world. The League of Women Voters has a long history of advocating for justice, fairness and safe, effective alternatives to mass incarceration at all levels, fully understanding the disastrous impact of incarceration on women and their children.

Demands of the COVID-19 Justice Coalition include:

- * Release any person in custody who does not pose a demonstrable imminent threat of bodily harm to someone else.
- * Release people as soon as possible.
- * Statewide and local decision makers must hold themselves accountable and share information daily with the public.

The Justice Reform Committee of the Charlottesville Area LWV focuses its education and advocacy on the front end of the justice system, examining how the positions of local police, sheriff, magistrates, prosecutors, judges and juries impact women and their families as well as the residual impact on the greater good of the area.

At the same time, the committee studies the potential for alternatives to incarceration needed now, such as Charlottesville's successful Georgia's House, founded by LWV member Dorothy Tompkins. Georgia's is a successful example of a frontend diversion for women. However, Georgia's can provide services to only

12 women at a time. The LWV Justice Reform Committee advocates for significant expansion of the Georgia's House concept, along with other community based programs that assist women with drug addictions, health care, job training, childcare and safe affordable housing.

The spread of COVID-19 underscores the need for immediate action followed by broader reform and community alternatives to mass incarceration. League positions and actions emphasize safe, effective, humane alternatives to incarceration.

Beth has been following national, state and local child care issues during the pandemic. She recently listened to a webinar, led by Jenna Conway and Tara Ragland, in which they discussed child care policies related to Phase 1 and Phase 2 of the opening process in Virginia in response to the Covid-19 pandemic. Jenna Conway is a member of Governor Northam's "Children's Cabinet" and she is in a leadership position, overseeing child care during the pandemic. Tara Ragland is the director of child care licensing. It has been good to see stronger child care leadership, coming from the state government, even if all of their policies aren't quite what the LWV CVA Child Care Committee would advocate for.

At the local level, currently there is not enough child care available to meet child care needs. Also there is concern that more centers will go out of business permanently. We are monitoring this unfortunate outcome of the pandemic.

Hi Anne,

Thank you for your email regarding the upcoming June Dual primary in Nelson County. Our Electoral Board did not have a meeting on April 7. They are not currently meeting on a monthly basis.

We have posted registration/absentee informational flyers and applications at the Post Offices and other locations around the county, reached out to both parties, and used social media to encourage voters to vote absentee by mail. All of our absentee ballots we are sending out have the revised instructions from the Department of Elections concerning not having to have a witness if they do not have one available. We do not have any radio or TV stations in Nelson County. There is a small weekly newspaper; however, it does not have wide circulation within many parts of our county.

We are working to ensure as much PPE for our polling places as possible. We have had cloth masks made and donated by the spouse of one of our officers of election for all of the workers. We are also securing disposable masks, gloves, disinfecting wipes and alcohol spray bottles to clean our voting equipment. The Department of Elections has advised that they are sending us single use pens for ballot marking that the voters will take with them. Our maintenance departments are building sneeze guards for the tables where our workers will be sitting to separate them from the voters. Our precincts will be marked on the floor to guide social distancing for our voters. Privacy screen voting areas will be separated for social distancing. We plan to have signage at each polling place advising the voters what to expect once inside. This is an ongoing and evolving project. We are trying to be as proactive as possible within the supply limitations we have faced trying to obtain PPE for the June primary.

We do not know what will be in place for November and will address that at a later time as we are now currently working to ensure the integrity and safety of the June primary.

Absentee ballots--Voting by absentee ballot seems to be encouraged due to a concern regarding CV-19 and a possible lack of workers and social distancing. Voters must apply by June 16 although it is noted that there will be a very short time to process and return a ballot. Code 2A is the reason for requesting said ballot and voters must remember to indicate whether they want to vote in a Democratic or Republican primary. Ballots are to be returned by mail or can be brought into the office with a proper ID. Voters can only bring in their own ballot. If mailed, people can call the office or send an e-mail to be certain that the ballot was received. Regarding absentee ballots, Jennifer Lewis-Fowler is quoted as saying that she believes that fraud is minimal since ballots are mailed directly to the person who has registered. Then the ballots are returned by mail or in person with proper ID. There are no outside collection boxes.

Problems:

- --Someone to monitor the number of voters at a precinct at any given time.
- --Possible pre-processing absentee ballots
- --Training regarding increased health safety standards (PPE protocols)

Most recent first: I delivered our AB ballot applications to the registrar's office when I went to volunteer on Thursday. They reported being 'swamped' by applications [including many for the November General Election]. We received ours in the mail Saturday.

The Electoral Board met 10 am-12:45 pm on 5/7, and planned to continue with the closed session to discuss security procedures on 5/13 after a longer than planned meeting ran into one member's deadline.

The vendor for the ballot readers is not planning to come to the county, so the electoral board [EB] & Registrar will need to do the programming and L & A testing [logic & accuracy]. All the electronic materials are now programmed. The EB decided to go through the L & A process, & call for tech help only if needed.

90 surveys had gone out to potential Officers of Election [OEs] the night before. 47 responses had been received. Very few positives. Many OEs are in the most susceptible to Covid 19 category, and quite a few respondents had indicated they were waiting to see how the 'opening up' would go to judge the riskiness of serving. The EB will ask the county's help to recruit younger workers.

Plans are in place to do mainly on-line training, both with materials from the state, and with local videos. They need to do in-person training with Chief/Asst Chief/ & Admins. They hope to do this in a tent sometime after 6/10 = prefer 6/13, since that is before the office is open on Saturday for the last days of in-person absentee voting.

The state will be sending PPEs – in the form of 'sneeze guards' The EB discussed sanitizing procedures & cautions [don't get the chits or ballots wet – info will disappear]. They will send a memo to the Health Dept to ask for any other suggestions, and will send out to OEs who will be serving

The final discussion was on how to encourage AB voting, and to counter the myths that the votes would not be counted – this was of special concern after the fiasco of the primary election this spring in Wisconsin. Again, the issue is how to get the word out.

LWV CVA Natural Resources Committee Meeting Summary by Muriel Grim

The Natural Resources Committee held a Zoom virtual meeting on May 21, 2020.

We discussed the request for a special use permit for the proposed (Boyd Tavern Market) service station at the I-64 interchange at Exit 129. This is another issue made very complicated because of the "stale zoning" problem. After a long public hearing on 20 May, the Albemarle County Board of Supervisors decided to postpone a vote until June 17. According to the Comprehensive Plan this is not an acceptable use for that site. But by being zoned "commercial" it would be an acceptable use. A decision either way would be legally defensible (or indefensible). Also arguments can be made either way for the development of this proposed combined gas station and store at the site.

Climate Action Plan: We decided to send a statement of support for the Climate Action Plan (CAP) to the Albemarle County Board of Supervisors in time for its work session on June 17. We intend to focus on how the specific actions in the CAP support the Comprehensive Plan and area Master Plans. The CAP actions show ways that the Comp Plan goals can be achieved.


This discussion led to again considering the need to educate the community about the Comprehensive Plan and also the fact that all land use should now be looked at in its relationship to climate change.
