# October 18, 2 to 3 pm "LWV-VA Affordable Housing Study" Review and Consensus Meeting

**Guest Speaker: Alice Tousignant, LWV-VA Study Leader** 

Reason for Study of Affordable Housing: The LWV-VA Affordable Housing Study was initiated by the LWV-Richmond Metropolitan Area, in response to revelations in Mathew Desmond's Pulitzer prizewinning book, "Evicted," that the City of Richmond had the second highest eviction rate in the nation and nine other Virginia large and small cities were among the top 10 highest. A new, statewide study of affordable housing was approved at the LWV-VA Convention in June 2019. Safe, affordable housing is a health issue, economic issue, and environmental issue, as well as a moral and equity issue.

The focus of this State-wide study of affordable housing is very low and extremely low-income households who are primarily renters. In addition to characterizing the state of affordable housing in Virginia, the study:

- Outlines resource options available at the state and local levels to increase the supply of affordable housing and preserve the existing affordable housing stock;
- Identifies the most important barriers that stand in the way of development of this type of housing; and
- Brings to light laws and regulations that make it difficult for very low and extremely low-income households to find and maintain their housing.

At the Sunday Seminar on **October 18, 2 – 3 pm**, LWV-VA Study Leader Alice Tousignant will lead the review and discussion of this important study and "Consensus Questions" (see page 2 of this newsletter). #### **BALLOT QUESTION #1**

Should the Constitution of Virginia be amended to establish a redistricting commission, consisting of eight members of the General Assembly and eight citizens of the Commonwealth, that is responsible for drawing the congressional and state legislative districts that will be subsequently voted on, but not changed by, the General Assembly and enacted without the Governor's involvement and to give the responsibility of drawing districts to the Supreme Court of Virginia if the redistricting commission fails to draw districts or the General Assembly fails to enact districts by certain deadlines?

#### **BALLOT QUESTION #2**

Should an automobile or pickup truck that is owned and used primarily by or for a veteran of the United States armed forces or the Virginia National Guard who has a one hundred percent service-connected, permanent, and total disability be free from state and local taxation?

#### Who is Eligible to Register to Vote?

- A United States citizen
- At least 18 years of age by November 3
- · A resident of Virginia
- Those convicted of a felony or judged mentally incapacitated in any state must have proof of restored voting rights

#### When and How You Can Vote?

#### **By Mail**

- Complete an online application for an absentee ballot go to <u>elections.virginia.gov</u> and click on "Casting a Ballot" – You can track the date your registrar mails you your ballot
- <u>OR</u> call your registrar (numbers above) and request a ballot be sent to your address; the registrar will then mail you a ballot
- Mail-in ballots must be postmarked by November 3 and received by noon on November 6
- OR drop off your ballot in a "drop box" at your registrar's office through November 3 or at your polling place on Election Day

#### In Person

- Vote at your registrar's office (addresses above) now through October 31 – ID is required
- OR Vote on Election Day, November 3, at your precinct
   ID is required

- 1. A constitutional amendment creating a bipartisan citizen-led redistricting commission is necessary to achieve binding redistricting reform.
- 2. A bipartisan, citizen-chaired redistricting commission with an equal number of legislators and citizens would draw the voting maps.
- 3. The process will be much more transparent with the redistricting public hearings and data open to the public.
- 4. There are strong criteria for the protection of racial and ethnic minorities and fair district maps.
- 5. If the maps fail to be drawn or enacted, the responsibility for drawing the maps transfers to the Virginia Supreme Court. In the past, courts have engaged "special masters" who are experts in drawing voting districts.

We talked about private companies that do curbside recycling. At this time two companies are operating, Evergreen and Quality Trash Disposal. Both practice source separation. We discussed the problem of changes in zoning and in development project plans. We also discussed complications caused by conflicts between outcomes of a development, for example, enlarging a service station potentially causing environmental and traffic stresses and appropriate architecture design problems but allowing people to drive less in order to get work done locally.

# **LWV CVA Child Care Update**

With funding a big issue in local child care right now, Beth has been following advocacy at the federal and state level, since subsidies usually come from those levels of government. There are a few, but not many, child care advocates in Congress and The Virginia General Assembly.

Congresswoman Jennifer Wexton, (Representative, D-VA 10th district) held an online event about child care, on September 2, 2020, which Beth attended. The child care industry needs a large scale immediate bail out or a high percentage of centers will go out of business. Additionally, since most of the people who work in child care are women, if centers close, this will mean many jobs lost for women. During the online event, people who work in child care were given the opportunity to explain in detail, why they might go out of business. One of those reasons is that most of them are not operating at full capacity, due to the pandemic.

Beth watched a documentary. "Through the Night", with the Blackstar film festival, out of Philadelphia. It was a documentary exploring the personal cost of our modern economy through the stories of two working mothers and a child care provider. As league members have previously discussed, often real life stories are helpful in understanding an issue like child care, in addition to policy or regulatory facts.

## LWV CVA International Relations/Federal Government Committee Update By Gerry Kruger

The International Relations/Federal Government Committee met virtually on Zoom on September 16 after months of pandemic stay-at-home regulations. **Elizabeth Frank's** report on Cuba, based on her own personal trips to Cuba in 2012 and 2013 as well as much research, was a combination of historical information and fascinating details from the 1800's through the Batista and Castro eras to present day.

Ever since Fidel Castro overthrew the US-backed Batista government and made Cuba a Communist country, the United States and Cuba have had strained relations. The Cuban Missile Crisis of 1962 almost escalated into war when the Soviet Union deployed ballistic missiles in Cuba. Ever since that crisis, the United States has imposed an embargo on Cuba that remains to this day.

After the fall of the Soviet Union in the 1990's, Cuba no longer received subsidies from the Soviets, and much suffering and hunger prevailed. But many resourceful Cubans learned how to make parts for old cars and appliances and began successful businesses. Elizabeth showed us a picture of beautiful goblets made from coke bottles. Cuba has an excellent health care system, and medical school is free, as is all schooling.

Tensions between our countries have both eased and intensified over the years. Fidel Castro met with President Nixon in 1959 and with Malcolm X in Harlem in 1961 before the Missile Crisis. In 1977 President Carter lifted the travel band, and he is still revered in Cuba today.

But the travel ban was restored during President Reagan's term. George W. Bush said if there was a chance for democracy in Cuba, it would come from within. However, President Obama and Raul Castro both desired better relations, and in 2015 travel restrictions as well as immigration policies were eased.

In 2017 Trump rolled back these policies and all engagement between the two countries stopped. Trips to Cuba are now limited to those offering help to the Cuban people. Flights from the US can only go in and out of Havana.

Our committee, as always, enjoyed visiting with each other again, although virtually, and Elizabeth's report was a reminder of how much we have missed learning more about our world from each other. The next "zoom" meeting of the IR/FG Committee is scheduled for Wednesday, October 21, at 10 am.
