How's Our Water and Who's Paying Attention To It?

At the LWV CVA *Sunday Seminar* on February 21 the Natural Resources Committee will introduce some of the people who are taking care of the Charlottesville area's water. Join us to find out about them and their water protection efforts.



Two decades ago the LWV CVA produced "Water in the New Millennium," a report that described the state of the area's water supply system and recommended steps to guarantee an adequate future supply of safe drinking water. Now we are taking a bird's-eye look at what is being done to protect our water from the time it falls onto the local watersheds, with some of that becoming our drinking water, until it makes its way to the Chesapeake Bay and Atlantic Ocean.

Water is vital to sustaining life on earth. As stewards of our natural resources we are obligated to take care of this most precious resource. Locally there are many people, organizations, and government agencies that work to keep our water safe and sustainable. At our February *Sunday Seminar* some of them will give us brief descriptions of how they are addressing problems and/or challenges facing the area's water. National Popular Vote Interstate Compact Support SB1101 (Ebbin) and HB1933 (Levine)

Executive Summary. SB1101 and **HB1933** would add Virginia to the list of **16 states** that are already members of the National Popular Vote Interstate Compact. Without amending the US Constitution, the Compact is the only way to ensure the US President will be elected by the popular vote of all voters.

Issue. The goal of the National Popular Vote Interstate Compact is to ensure that every vote matters in presidential elections, so all voters have a fairly equal voice in the election.

Joining the National Popular Vote Interstate Compact will **restore power to the voters**, instead of disenfranchising millions

What is the Compact?

- The Compact will guarantee the Presidency to the candidate who receives the most people's votes across all 50 states and the District of Columbia.
- The Compact is a **state-based approach** that **preserves the Electoral College**, **state control of elections**, **and the power of the states** to control how the President is elected, without having to amend the US Constitution.
- 16 jurisdictions with 196 electoral votes have already joined the Compact, including 4 small states (DE, HI, RI, VT), 8 medium-sized states (CO, CT, MD, MA, NJ, NM, OR, WA), 3 big states (CA, IL, NY), and the District of Columbia. The bill will take effect when states that collectively have 74 electoral votes enact it. A state may choose to withdraw from the compact.
- The Constitution supports the Compact, by allowing a state the flexibility to award all of its electoral votes to the candidate receiving the most popular votes in the nation.

How Will the Compact Work?

- The National Popular Vote Interstate Compact will go into effect when enacted by states possessing a majority of the electoral votes—that is, enough to elect a President (270 of 538).
- Virginia, if added to the Compact, will award its 13 electoral votes to the candidate who receives the most votes across all 50 states and DC, regardless of which candidate wins Virginia.

LWV CVA Firearms Safety Committee Report by Beth Alley and Maggie Hoover

Several members of the LWV Gun Violence Prevention committee joined numerous other GVP groups across the state to participate in a large virtual rally on Martin Luther King's Day. Governor Northam, Attorney General Herring and other prominent figures in the struggle for Sensible Gun Legislation all spoke at what was the 29th rally in support for this issue. In light of the current events in Washington DC and across the Nation more than ever, it is crucial to improve gun safety laws in the interest of public safety. The following is GVP Legislation which has been filed and has the League's support:

1) HB 2276 (Simon)

Prohibits the manufacture, import, sale, transfer of or possession of Ghost Guns, Downloadable Guns & Undetectable Guns

2) HB2081 (Levine)
Bans guns at polling places

3) HB1992 (Murphy)

Mirrors federal law that prohibits those convicted of misdemeanor assault/battery of a family member from purchasing a firearm

4) SB1381 (Ebbin)

Prohibits possessing or transporting a weapon within Capitol Square or into buildings owned by the Commonwealth. If passed, this would essentially codify the rules passed by the GA last year and codify Northam's executive order.

Justice Reform Committee Considers Popular Tactic: Bookgroup By Kit Murphy McNally, LWV CVA Justice Reform Committee Chair

Impressed with the successful bookgroup format of the LWV CVA Natural Resources Committee study of the Albemarle Comprehensive Plan, the Justice Reform Committee will discuss adapting a similar path to understanding and supporting justice reform at the February 19 meeting at 11 am via zoom.

The potential for justice reform is promising in the Virginia General Assembly session underway, along with actions already being taken by local Commonwealth attorneys and new presidential support for justice reform nationally. The challenge the Justice Reform Committee faces is acquiring a solid understanding of what problems remain for women caught up the system and how new local, state and national actions can be supported to enhance justice for more women in the local five county area.

The pursuit of deeper understanding by way of bookgroup heads the agenda for the February 12 meeting on zoom at 11 AM. Committee member Traci Griggs proposed a process for study which may stand as framework for a bookgroup.

The committee has discussed the value of prosecutorial discretion in sentencing, the problem with cash bail, alternatives to incarcerations, mental health training for police, crisis intervention teams and restorative justice, among other evolving practices focused on front end alternatives in the community. But the process of reading materials specifically related to issues of women caught up in the justice system, then calling on justice officials to discuss the situation through an interactive zoom session is a new approach.

The outcome of justice reform legislation in the current short term of the General Assembly may produce opportunities for local reform and measurement of success. The *League of Women Voters of the Charlottesville Area* will be watching any new laws, and the how the related actions of police, jail administration, commonwealth attorneys and courts impact women in the LWV CVA area (city of Charlottesville, and counties of Albemarle, Fluvanna, Nelson, Greene and Louisa).

Progressive prosecutors in Albemarle and Charlottesville are already proposing or using front end options such as the elimination of cash bail, supervised pretrial release, treatment court and some alternative referral to programs such as *Georgia's House*.

Much has been studied and written about the justice system in recent decades. The *National Institute* of *Corrections* is just one entity that has studied sentencing alternatives in depth and given judgment on success. But success is not a hard and fast point in a life. Everyone and every practice evolve. The LWV CVA and its Justice Reform Committee are watching, learning and speaking up.

LWV CVA International Relations/Federal Government Committee News By Gerry Kruger

The International Relations/Federal Government Committee met virtually on January 13, 2021 and continued our study of the Middle East. **Bobbie Williams**, who had visited Iran in 2016, treated us to a comprehensive review of Iran's history from 500 until today.

The people of Persia, as it was originally named, have retained their culture throughout history in spite of being invaded, captured, and used as a waterway from Asia to Europe. Despite being taken over by the Greeks and Romans and later the Turks, they managed to retain their belief in the one God of Muhammed's vision in the late 500's. Muhammed's daughter married Ali. After Muhammed's death, the Muslims split into Shi'a and Sunni. Shi'a Muslims are descended from Ali and the Sunni are Arabs. The Sunni were the upper class and had power as well as wealth. The Shi'a were common people such as farmers and traders. Today there are three divisions in Iran. The third group is made up of poets, dancers, Christians, and Jews.

For centuries the Ottoman (Sunni) and Persian (Shi'a) Empires were at War. Eventually the Ottoman Empire became Turkey, less religious and more westernized. The Pahlavi line came into power in Persia in the 1900's. The first shah changed its name to Iran, westernizing it and giving women more freedom. The clerics had power over religion and the shah had power over politics.

After World War I the British drew new boundary lines that separated Iran and Iraq. After World War II, the son of the first Shah gained power with the help of the US, but eventually was overthrown by the clerics. The Ayatollah Khomeini took control of all aspects of government and shredded all western influence, again putting restrictions on women, movies, and outside news. When Khomeini died, the new ayatollah took over. Ayatollah Khameini is a holocaust denier but is not as strict and allows the people more freedom.

When Bobbie was in Iran in 2016, their guide told them they weren't allowed to take pictures of the embassy where the hostages were taken captive during the Carter presidency. He told them that Iran is only using uranium for medicine and utilities, and the US is considered a terrorist government because of its support of Israel, who has nuclear weapons. The people say they have nothing against Americans, just their government. They blame the US for our treatment of Iraq. Iran has a Parliament, which is called the Council of Guardians, but the ayatollah can overrule it.

During the Obama administration Iran agreed not to enrich uranium for ten years. Inspectors oversaw their destruction of large centrifuges. Then President Trump pulled us out of the agreement.

Overall, Bobbie felt safe during her visit. The people were friendly and sold beautiful textiles, and the museums and art were fabulous. To learn more about Iran, several members recommended reading *Desert Queen* by Janet Wallack. It's about the life of Gertrude Bell and has been made into a movie called "Queen of the Desert." Our next virtual meeting will take place on February 17 at 10 am. Join us as Lydia Peale discusses the roots of the Arab-Israeli conflict. Albemarle County Electoral Board Virtual Meeting January 13, 2021 DRAFT Minutes submitted by Kerin Yates, LWV CVA Electoral Boards Observer Corps

Location: Albemarle County Office Building, 5th Street

The minutes for December 9, after a modification by Peter concerning drop-off centers, were unanimously approved. Letter from Electoral Board to Board of Supervisors (BoS) and others requesting a work session concerning budget and space needs. The response to our letter was discussed. Jake noted that BoS Chair Ned Galloway responded that Jake should confer with Lance Stewart, Director of Facilities and Environmental Management, about our space needs going forward. This has happened. Lance has determined that, due to many staff in our building continuing to telework, we should be able to continue to use the 5th Street Office Building for our regular office and for Early In-person Voting (EIP). It was determined that we could use Conference Room A for general elections and Conference Room B for primaries. Jake has asked that Lance put that in writing. There was a suggestion that Lance also confirm this in writing with the BoS. Jim asked that Jake set up a meeting with the Office of Management and Budget to discuss budgetary issues.

Public Confidence in Election Integrity. Michael proposed lobbying ELECT to implement a program to explain election integrity in Virginia to the public. Discussion ensued. Michael agreed to draft a letter explaining what we think is needed and share it with the Virginia Electoral Board Association. Risk-limiting Audit (RLA). Plans for holding a statewide RLA of the November 3, 2020 presidential election in February were discussed. Election Official Management System Upgrade. Clarice and Erin noted that they have checked out a new software system for tracking our election officials. As required, the County's Information Technology Department has been sent a notice of what is in the new proposed system. Discussion ensued. Election Official Appointments. Jake asked Clarice to send notice to the County political party chairs informing them that it is time for them to recommend appointments.

DRAFT Executive Session. Michael moved the following: RESOLVED, that the Board enter into executive session for the purpose of discussion of the performance of employees, as provided by section 2.2-3711.A.1 of the Code of Virginia. The motion passed unanimously. The Board went into Executive Session at 9:58 am. The Board came out of Executive Session at 10:30 am. Michael moved the following: RESOLVED, that to the best knowledge of each member of this Board (i) only public business matters lawfully exempted from the open meeting requirements of Chapter 37 (Virginia Freedom of Information Act) of Title 2.2 of the Code of Virginia and (ii) only such public business matters as were identified in the motion by which today's executive session was convened were heard, discussed or considered in the executive session. The motion passed unanimously.

The meeting was adjourned at 10:31 am.

Cybersecurity Assessment

The Cybersecurity Assessment was keyed into Integra prior to the December 31, 2020 deadline.

Redistricting

The Division of Legislative Services has released a Guide to Local Redistricting. The U.S. Census Bureau will be releasing numbers to the Commonwealth on April 1, 2021.

Precincts

A short discussion was held regarding selected precincts that the Electoral Board and General Registrar would like to move/merge dependent upon redistricting border changes. Yancyville, Cuckoo, and Trevilians Fire Station. [Note: I will also follow-up with this at the next meeting. KD]

Election Officers

The Louisa County Electoral Board and General Registrar are reviewing Election Officer assignments with a plan to ensure equal party recognition with Chief, Assistant Chief, and Backups for both positions.

Election Officer Training

Election Officer Training in 2021 will require the additional training to assess the new equipment and procedures to include a new Electronic Pollbook, scanner, and printer.

Triggering Events

Triggering Events were reviewed respective to 2021, knowing that many documents will need to be updated to address new procedures, new equipment, and a possible office move.

Chairman's Report

After Action Review of the November Election: The after-action review of the November election was attended by members of the community and commonwealth. The one hour brief was met with high approval by all who attended.

Mrs. Wolf presented the possibility of designing a pamphlet to inform the voting community of the entire voting process including registration, mail in voting and in-person voting. She also plans to include frequently asked questions.
