**2020-21 LWV CVA Program Planning Update:** On December 6, 2020, a virtual Program Planning Meeting was held with 18 LWV CVA members participating. Under review at this meeting were **Local Program and State Program** in preparation for member approval at the 2021 LWV CVA Annual Business Meeting (May 3, 2021) and the LWV-VA Convention (June 5, 2021).

On December 16, 2020, the LWV CVA Board reviewed a Draft Report of the December 6 meeting at its monthly Board meeting. Carol Cutler, LWV CVA vice-president, presided over both of these meetings and has prepared the report for review by members—see page 4-5 of this newsletter. We will continue to use the coming weeks to prepare the final draft of this report for members to review for consideration at the Annual Business Meeting on May 3, 2021. We await the official feedback form from the State League to submit our State Programs report.

## LWV-CVA Program Planning for 2020-21 Report

1. Is there a new study (one only) <u>on a local issue</u> you would suggest? Describe issue and give scope for the study. Volunteers willing to work on the study. Yes. The LWV CVA Justice Reform Committee, in accord with state and national LWV policies, will study elements of the local criminal justice system to ensure fairness and equity for people who may be affected by Virginia's state and local systems of justice.

**Volunteers willing to work on the study.** Kit Murphy McNally and LWV-CVA Justice Reform Committee. (Preliminary to the study, Kit McNally and Frances Schutz will compose a statement that reflects current state or national justice reform positions and include Justice Reform as the seventh category under social policy for 2021. This will be reviewed by the Board by March 1 and may be approved at the Annual Meeting.

2. Is there an update (restudy) of a <u>current position</u> you would suggest? List reason for restudy and define scope.

1) Yes. Continue to study the "Education" position to assess the need for increased internet access and cyber education in schools. **Volunteers willing to work on the continuation of the study:** Michele Kellermann, Carolyn Fitzgerald

2) Yes. Continue to study the "Health and Family Life Education and Health Services in Area Public Schools" position to assess how behavioral health matters are handled in the schools; training for school personnel in recognizing crisis behavior; and the adequacy of the FLE curriculum to address positive coping skills, resilience and suicide prevention. **Volunteers willing to work on the continuation of the study:** Mimi Bender, Carol Cutler

## Local Program Planning Addendum

The following is a draft of suggested rewording to Local Program as discussed at the Program Planning meeting on December 6, 2020.

#### **Election Integrity**

#### Suggested Rewording to clarify:

Support local citizen awareness regarding potential security vulnerabilities in election systems, as well as the disruptive nature of disinformation campaigns and voter suppression tactics. Work with and support local registrars and others to address these concerns as needed, and thereby strengthen the integrity of election outcomes. Support transparency and accountability in post-election audits. Disseminate voting information to local citizens about upcoming elections by issuing public service announcements, offering nonpartisan candidate forums, and other means.

#### From Shirley Payne)

My suggested revision for our League's Election Integrity position follows. Also, here are a few points I had in mind while drafting it:

- I think the current reference to the LWV-VA position is unnecessary. There are only two other positions in the handbook that include this language, yet multiple others correlate to state positions. The reference just doesn't add anything, in my view.
- I purposely replaced "vulnerabilities in *our local election system*" with the more general "vulnerabilities in *election systems*." Our public awareness efforts would, I believe, never spotlight specific security problems in our local system. The registrars would never forgive us!
- I left out "risk-limiting audits" because it's a term I think quite a few people don't yet understand. I believe the word "audits" could be interpreted to include the risk-limiting audits.

Currently in program handbook:,,,,"support public education on vulnerabilities in our local election system and the potential for disruptive disinformation campaigns or voter suppression. (remove , and) Work with others, such as local registrars, in making our voting systems accurate. Support transparency, security, and accountability in local post-election audits and risk-limiting audits. Support dissemination of local voting information by public announcements and offering nonpartisan candidate forums. [2020]

#### **Sustainability Accords**

Action: Support of the Sustainability Accords, (TJPDC, 1998) particularly of the section on Government–-'Goal: Governmental decisions are made in an environment that promotes widespread, informed, and civil public participation.' (could not find this in sustainability accord document) [1990] Suggestion to add the word "transparent." Suggested "Reaffirmed in 2007)

## LWV CVA Child Care Committee Report by Beth Kariel

The Child Care Committee recognizes that the problems we identified in our 2017-2019 study update are currently being addressed at the state level of government.

Going into this year's General Assembly, Governor Northam is proposing key funding measures for Early Childhood Care and Education. These include restoring initiatives for the public pre-K pilot program and an incentive grant to attract future early educators to the field as well as addressing pay for early educators.

We continue to think it's important to acknowledge the work and advocacy of First Lady Pamela Northam for her work to improve Early Childhood Care and Education and to address issues of equity in child care.

As we've noted before, the 2020 General Assembly passed transformative legislation which created one unified point of accountability for Early Childhood Care and Education in the Department of Education and a uniform quality rating and improvement system by 2023. All of that work is continuing, despite the pandemic.

At the December 22<sup>nd</sup> meeting of the Natural Resources Committee we concentrated on preparations for the February Sunday Seminar. Twenty years ago the LWV-CVA wrote a report on the quality and quantity of our local water supply and what should be done to protect it. The February seminar will focus on water, our most valuable natural resource. In addition to changes to water protection over twenty years, we will highlight water-related activities of local environmental groups. The NRC will meet virtually on Tuesday, January 5 at 1 pm to finish planning for this event, especially how to organize presentations by representatives of the environmental groups. ## **TRANSFORMATIVE** Defines Justice Pursuit by Kit Murphy McNally, Justice Reform Committee chair

After a December hiatus the LWV CVA Justice Reform Committee gears up for a structured 2021 focus directed at transforming the system as it impacts women – at the front end. Specifically, the Committee is delving deeper into the efficacy of alternatives to incarceration in jail or prison that have proven effective through research and practice. Of those, what could potentially be expanded or adopted in the greater Charlottesville area and what are the barriers to change?

The starting point aims at a broad five county\* examination of:

- how the system is working locally;
- current alternatives and diversions;
- data evaluations and recommendations;
- local impact of recent justice reform legislation in the General Assembly;
- actions of local commonwealth attorneys; and
- how women are affected overall.

\*LWVCVA includes Albemarle, Fluvanna, Greene, Louisa, Nelson Counties and Charlottesville City.

The Committee has already compiled information and data on some existing diversions such as *Georgia's House,* and alternatives overseen by Offender Aid and Restoration with results in the Thomas Jefferson Planning District researched and documented by Neal Goodloe [presented at the April 2020 Sunday Seminar via zoom].

Committee member Traci Griggs has outlined a thorough process to guide the committee as it works through 2021. Part of that process will engage an understanding of recent and continuing justice reform emanating from the Virginia General Assembly and local Commonwealth Attorneys. For example, Fairfax Commonwealth Attorney Steve Descano, recently eliminated cash bail – a long known disparity in the administraton of justice --in his northern Virginia jurisdiction. Additionally, the LWV-VA has connected leaders of League justice committees throughout the state, so the work of one is shared with all. For example, the Arlington LWV has researched and proposed adoption of restorative justice, a practice developed in the early 1980's with scattered implementation across the nation.

More justice reform is anticipated in the short session of the General Assembly this month extending an atmosphere of reform at the state level to engage and drive LWV CVA justice initiatives and action.

# International Relations /Federal Government Committee News by Gerry Kruger

The International Relations/ Federal Government Committee met on Zoom on December 16th. **Rice Wagner** reported on her in-depth study of the recent \$23 billion arms deal between the US and the United Arab Emirates. Two procedural votes failed to gain a majority in the Senate and block the sale. They failed by votes of 47 to 49 and 47 to 50. All but two Democrats voted to block the deal. One Republican broke ranks to vote against the sale.

The arms deal will allow the sale of three types of military equipment:

- 1. F-35's, fighter jets that ate considered the "best of the best."
- 2. Drones
- 3. Air to ground and air to air missiles

Those against the deal, which also includes some human rights groups, argue this will create more instability in an already unstable region and cause the number of migrants fleeing war to increase. Democrats are opposed to the arms race it could promote. They also cite the UAE's treatment of Yemen and links to al-Qaeda and China as well as sending arms to Libya.

Those who argue for the agreement want to militarily support countries that could aid in the fight against Iran. They also say it will create jobs in the US and help American workers.

In addition to the arms agreement, Rice informed us of the Abraham Accords signed on September 15, 2020. It's referred to as a peace accord, although the countries involved haven't been at war: UAE, Bahrain, and Israel. On October 23, Sudan, which has been labeled as terrorists by the United States, joined the accord. Although Prime Minister Benjamin Netanyahu signed, he still wants to have more arms than the other countries. Two groups that stand to lose the most are the Iranian leadership and the Palestinians. Our committee plans to discuss both groups in future meetings, beginning with Iran.
