# Safe and Secure Ballots:

What Voters Need to Know

"Voting Security" is a hot topic during election season. Now with 24-hour news cycles and social media, information relayed to the public can be founded or unfounded or just plain false. How can voters tell what goes on in their city or county to make sure all ballots are counted securely and carefully?

To help us understand voting security, LWV CVA has invited two speakers who are election officials from Albemarle County and Charlottesville City to describe to us what the voting process actually entails. Jake Washburne, General Registrar of Voters, Albemarle County, has been the County Registrar for over 15 years, and is responsible for implementing requirements of state and federal voter registration and elections law for 71,000+ registered voters, voting in the 28 County voting precincts. Taylor Yowell is Acting Director of Elections and General Registrar for the City of Charlottesville and serves the city's approximately 34,000 voters in four wards with nine voting precincts. Both registrars will show us what voting security looks like in their jurisdictions from registration to counting of ballots.

The LWV CVA Voter Services Committee invites you to attend this Sunday Seminar, the first this 2021-2022 year, as part of our effort to expand the knowledge of the fully engaged voter. Please note the meeting will be held in the Swanson Room (previously McIntire Room) – take the elevator to the third floor of the Library. ### "Ordinance 21-10 passes in Albemarle County"

Albemarle Board of Supervisors unanimously approved **Ordinance 21-10** that bans guns from buildings, parks and community centers owned or used by the county for governmental purposes. Charlottesville passed a similar ordinance last year. There was discussion about Crozet and other areas not appearing to follow the comprehensive plan as they proceed with development. We should monitor this and prepare to comment on it.

# LWV CVA Justice Reform Committee Learns about Magistrates By Kerin Yates, Justice Reform Committee

The LWV CVA Justice Reform Committee (established at our League's 2018 annual program planning meeting) knew from the start that we wanted to learn of ways in which we might assist in promoting positive prison reforms especially for women. We were aware of many of the problems that seemed to exist, but we also knew we were not well versed in actually how the Virginia criminal/judicial system was organized or worked – knowledge necessary for any forward movement. Since then we have been learning! This report covers in part our committee Zoom meeting held August 19 which focused on magistrates.

Why learn about magistrates? We had become aware of the fact that a citizen's first contact with Virginia's Judicial System is with a magistrate and we knew little of the requirements for the position. James Hingeley, Albemarle Commonwealth Attorney, told us "They generally get little attention, although they play an important role in administering criminal justice in Virginia." Two magistrates who happen to be women met virtually with us on August 19: **Avnel Coates, Region 4, 16**<sup>th</sup> **Judicial District Chief Magistrate; and Cheryl Thompson, Region 4, 16**<sup>th</sup> **Judicial District Supervisor.** They were forthright and outstanding in responses to our questions put forth by committee members including: Who hires and pays them? Are they non-partisan? How do their daily jobs evolve? Do they determine bail? How do they see their responsibilities? What made them apply to become magistrates? Do they find their jobs interesting? They took the meeting from there.

"Who hires and pays and oversees the magistrates?" - Although the Executive Secretary does officially hire, we learned it is the **Chief Magistrate** and the **Regional Supervisor** who do the ground work. It is a long, long process. Before 2008 when the system was restructured there were no specific requirements to be a magistrate. The position now requires that one have a bachelors degree but not in any particular field. (Those in positions prior to the restructuring were grandfathered.) A law degree or the ability to read the law and do legal research is a plus because the position requires both. An example: One authority of a magistrate is to "issue an arrest process." The issue, such as assault and battery, is brought before them and it is the magistrate that decides if the complaint meets the Virginia code to issue an arrest process. The magistrate's insight or opinion has nothing to do with providing the issue of the arrest process or not. It is all "by the Virginia code". Applicants must pledge to be absolutely neutral and unbiased. (Should one wish to run for any political position or be a part of any partisan group, they must resign their position.) There is a great deal of "in house" training and oversight for new magistrates with continuing education annually for all.

Chief Avnel and Regional Supervisor Cheryl took us through their hiring experiences and the daily work of a desk magistrate, where all begins. They said that no day is the same and for each decision made, never will both sides be pleased. In addition to their administrative and supervisory roles both magistrates said they cherish the days they can "work the desk", where they are actually providing professional service to citizens. # Excerpts from Minutes from Electoral Board Meeting for Louisa County August 4, 2021

Report submitted by Karen Davenport, LWV CVA Electoral Boards Observer Corps

#### **NEW BUSINESS**

### Early Voting Hours are currently scheduled as follows:

Operations:

8:30 a.m. to 4:30 p.m. – Monday through Friday

Closed Columbus Day

Open on the following Saturdays - 8:30 a.m. to 5:00 p.m.

October 23rd and October 30th, 2021

Evening Hours – A motion was made and approve to have additional hours on Wednesday, October 20 and October 27 until 7 pm. The dates will be finalized and announced as defined by law.

### **Early Voting Facilities**

A discussion was held regarding the Early Voting Facilities currently offered. The facilities have been deemed an insufficient space to handle the election requirements for Election Officials, Observers, Voters, and ADA requirements. The e-Pollbook and Check In table may need to be placed in the hallway.

### **Ballot Order/Requisition**

Nine styles of ballots will be required for the November General Election. A motion was made for Mrs. Watkins to purchase enough ballots to cover 100% of registered voters (or minimum allowed) to meet the needs of the election. The motion was carried in acclimation.

### **OLD BUSINESS**

Officer of Election Split Shifts (24.2-115.1)

A discussion was held regarding the use of "split shifts"/allowing Election Officials to work half days. Several factors have been identified:

- 1. More Election Officials may become available if shorter shifts are available.
- 2. Louisa County is an agricultural community where residents have other responsibilities at home and in the community. By implementing a "Split-Shift" operation, workers would be able to work partial hours then tend to other responsibilities.

A motion was made by Mr. Haymore and seconded by Mrs. Wolf to allow the use of "Split-Shifts" provided the Election Officers identify an approved Election Official, coordinate with their Election Officer counterparts and coordinate such with the General Registrar. A paragraph describing the intent of the "Split-Shift" will be provided in the Election Officer's Training Letter scheduled to be mailed on or about August 5, 2021. The motion was carried by acclimation.

#### **Page Program**

A motion was made by Mrs. Wolf, seconded by Mr. Haymore as follows: The LCHS Page Program in support of the 2021 General Election will resume operations under the review of Mrs. Wolf. Mrs. Wolf will contact LCHS Mr. Harris to share additional information and training.

#### **Promote the Vote Day**

Laura Watkins, LCHS, (894-5436) is currently responsible for the "Promote the Vote Day". Mr. Koegle will contact LCHS to verify the status of Promote the Vote Day this year.

### **NEXT MEETING**

The next scheduled meeting of the Louisa County Electoral Board has been scheduled for September 9, 2021 at 1:00 pm.
