WHY VOTE?

The following article was written by our LWV CVA Community Engagement Director, Lisa Hilgartner, as an op/ed column to encourage people to vote in the coming November election. It is reprinted here as a guide for our LWV members to use to encourage all who are registered citizens to GET OUT AND VOTE!

**Why vote?** Virginia holds elections every June and November and this year our ballot has an important state-wide gubernatorial election and members of the House of Delegates along with many local races for city council members, county boards of supervisors, school board members, and other town positions. Even the best-intentioned voter who understands the power vested in the elected office holder may have a hard time finding exactly what is on his or her ballot. Often this leads to voter apathy. But if we've learned nothing else from the elections of the past decade, voting is the heart of our democracy, and we need all citizens who are eligible to cast a ballot to inform themselves and vote.

#### What does it take?

First, **make sure you are registered to vote**. If you have recently moved from another state or another part of the Commonwealth, you will need to register or change your registration to the voting district where you reside. You must have turned 18 on or before the next general election to be able to register to vote. If you obtained a driver's license when you were 16, you were not automatically registered to vote. You can verify this and apply online by going to <u>https://www.elections.virginia.gov/registration/</u>OR by going to your local registrar's office:

Second, **find out who and what's on your ballot**. It's important to know what government posts are up for the election and if there are any referendums or constitutional amendments that will appear on the ballot. This can be done by going to VOTE411.org, or elections.virginia.gov, or going to your local registrar's office's website to see a sample ballot.

Third, and this is an important step, **find out the duties and power these positions** have so that you can understand how decisions made by that elected office holder can affect your job, and your life and those of your family and friends. What can a governor do? What is the role of Lieutenant Governor? Just what does a Supervisor on the local Board of Supervisors do? It has been proven to be true that decisions made on the state or local levels have more impact on our day to day lives than federal government decisions. [A good resource is the latest book by David Toscano, *Fighting Political Gridlock* [Univ. of Virginia Press, 2021]. In his book, Toscano, a former Charlottesville City Councilor, and Virginia Delegate to the Virginia General Assembly, describes how states shape our nation and our lives.]

Finally, think of the issues that are important to you. Check out the positions that each candidate has. If they have a position on an issue that is dear to you, see if they have a specific plan for what they intend to do. If funding is needed for this, what funds will they use for it? Be wary of generalizations, or shallow promises. Check voting records for incumbents and campaign promises. Check out the positions of new candidates. These are often found at Vote411.org or on the candidate's website, Facebook page, Instagram account, or other media platform. Attending forums or debates, tuning in when they are televised, or later catching them on YouTube are other ways to find out more about the candidates. Engage in civil discussions with other voters. Don't rely on friends or political endorsements to make the decision for you. Their reasons for endorsements may not be in your best interest.

#### Virginia: Redistricting Commission Testimony

The League of Women Voters of Virginia has given its full support to the Virginia Redistricting Commission to provide fair and accurate redistricting maps. Locally, Michael Rodemeyer, has provided an update on the work on the Commission. Below is his email that alerts Leaguers in the Central Virginia area: The Republican and Democratic consultant map-drawers have released a second set of House of Delegate maps that include incumbents and political considerations. Perhaps surprisingly, the new proposals for Charlottesville and Albemarle have changed very little (if at all) from the first set. <u>VPAP</u> has good information on the maps.

The Republican proposal would continue to divide Albemarle into three pieces: one (75) combined with Charlottesville for a very strong Democratic district, one "competitive" district (76) that combines southern Albemarle with two other counties (Nelson and Amherst) all the way to Lynchburg suburb, and a third (74) strong Republican district that includes northern Albemarle and parts of Greene and Orange.

The Democratic proposal divides Albemarle into two districts. One (80), combined with Charlottesville, would be a strong Democratic district, and the second (81) including the remainder of Albemarle and a slice of Augusta county, for a "competitive" district.

The Senate proposals are not all that different and don't pose any particular issues — other than the fact that Creigh Deeds does not currently live in either of them.

Next week, the Redistricting Commission will be holding VIRTUAL hearings by region. Hearings for OUR region (Central VA) will be on Wednesday, October 6 at 4:00 pm. To testify, you need to sign up in advance by noon, Tuesday, October 5th. [Leaguers received the link in an LWV CVA "Action Alert" email sent on Friday, October 1—if you didn't receive it contact lwv@lwv-cva.org] This will be our best chance to influence the Commission before it submits final maps to the General Assembly. It's important to show that we care enough about this issue to SHOW UP. Virtual hearings make it easy.

But there are also two ways to leave **written comments**. You can go to the Democratic House of Delegates map: <u>https://www.virginiaredistricting.org/legdistricting/comments/plan/154/1</u> click on the 81st district, and then click on ADD COMMENT and comment away. You can also go to the Republican House of Delegates map

#### https://www.virginiaredistricting.org/legdistricting/comments/plan/155/1

click on district 76 or 74, then click on Add Comment and then write your comment. [You can also submit a comment directly by using the form found in our Action Alert email.] Tell the Commission:

- Don't divide Albemarle oppose the Republican House of Delegates map! It continues the long practice of political gerrymandering. The very rural areas (further away from Charlottesville) of Nelson, Amherst, Greene and Orange have little community connection to Albemarle.
- Keep Albemarle (and Charlottesville) together as a community of interest. Everyone in Albemarle shares economic and cultural ties to Charlottesville and the University of Virginia.
- The Democratic map shows that there is no need to divide Albemarle to get districts of equal population.
- The better way to get the additional 12,000 people to complete Albemarle's second district is to go south to Nelson (route 20 and 29 corridors), southwest to Fluvanna (Lake Monticello), or north to Greene county (Rt 19). Augusta is over the Blue Ridge and is much more connected to the communities west of the Blue Ridge.

#### LWV CVA Natural Resources Committee Meeting By Muriel Grim, chair, LWV CVA Natural Resources Committee

At the September 28 Natural Resources Committee meeting we discussed the importance of planning for the need to generate more electricity. Large industrial scale solar farms may severely damage the land on which they are built making it useless for natural habitat or agriculture. We strongly support the development of solar energy but will contact the Thomas Jefferson Planning District and the Albemarle County government about steps being taken to make sure the generation of solar energy does not do any environmental harm.

We also discussed proposed housing that might meet our standards for being truly affordable. Housing is affordable when it is located and designed so that the residents, whether owners or renters, can easily pay for the house and also for needed transportation, utilities, internet, child care, and community services.

On September 30 the Natural Resources Committee finished its "book club" format reading and discussion of the Albemarle County Comprehensive Plan. We will be submitting comments and suggestions during the comp plan updating process. #### LWV CVA Electoral Boards Observer Corps Report By Kerin Yates

The Albemarle County Electoral Board met on September 1. Increase of pay for election chiefs and assistants was passed: \$20 for chiefs, \$10 for assistants. Budget did not allow an increase for regular officers at this time. Decisions for how to do training for the November election were not set due to Covid. Recruitment of officers for the election was proceeding well.

Covid protocols: For VOTERS protocols will be the same as last year. OFFICERS will be required to be masked only while on duty. Personal protection equipment has been inventoried. Software for handling election official assignments, etc., remains a work in progress.

Final decision to have a day of Sunday voting was deferred. Sue Lewis suggested this might be helpful for 6 day a week employees.

It was noted that Witness Signatures are required for absentee mail-in ballots unless the Governor declared a health state of emergency. As of this report he has not. Board considered publicizing this requirement.

The electoral Boards of Fluvanna, Nelson, Greene, and Louisa have not met or have met and not posted minutes of their September meetings since the September newsletter.


#### LWV CVA Community Engagement Committee News By Lisa Hilgartner, LWV CVA Community Engagement Director

Our Community Engagement team working with the Voter Services Committee promoted the LWV CVA September Sunday Seminar using Public Service announcements and event calendars for local print and web media and Facebook, as well as radio and TV. We were fortunate to have CBS19 and NBC29 cover the event. We have all pitched in to work on the "Why Vote?" OpEd at the beginning of this newsletter.

National Voter Registration Day was heralded by NBC29 covering the kick off of the Governor's Challenge- an award for participating schools if they have 65% of their Senior Class registered to vote by April 30th, 2022.

An announcement is made each Monday morning on WINA 1070's *Plug Away Monday* at 7:45 with an update on election deadlines and urging voters to go to the polls this fall in this very important election.

# LWV CVA Justice Reform Committee: Meeting the Challenge of Doing Justice By Kit Murphy McNally, chair

The Justice Committee took a deep dive into the front end of the Justice System in August during a highly informative zoom visit with Charlottesville Chief Magistrate Avnel Coates and Judicial District Supervisor Cheryl Thompson. Now the committee must wrestle with 'where to next?" Should we follow women (or everyone) further through the system here step by step or should we follow them after front end diversion? What alternatives exist in our five county area? How successful are the programs? What needs strengthening, expanding? What has been a successful diversion from incarceration elsewhere that does not exist here? Are there disparities in services available in our areas of service: Albemarle, Charlottesville, Fluvanna, Greene, Louisa, and Nelson? Should the committee confine its focus to women? There are by far more men caught up in the system—but women are often the primary caregivers of the children who too often are deeply affected or ultimately wind up in the system as well. Justice is a small word for a huge overlying crisis in too many neighborhoods and homes. Understanding the power of that word to hurt as well as heal opens avenues to progressive change. So, here at the crossroads, what road should the committee go down?

Join us via zoom October 8 at 11 am to share your thoughts, concerns, and passion to understand and support positive legislative and systemic change embedded in LWV-VA and LWV-US positions on justice.
