June Primaries – Are there any in *your* district?

Dear LWV CVA Members, On Tuesday, November 8, 2022, general elections will be held to choose your district's representative to the US Congress with party primaries in Virginia scheduled for June 21. With redistricting now in place for central Virginia, you should check if your district and voting precinct have changed as there are some interesting updates! Go to the League's VOTE411.org to check your registration and district information. Our League's area covers the City of Charlottesville, and the Counties of Albemarle, Nelson, Greene, Fluvanna, and Louisa, and the newly drawn districts are noted the following report by our LWV CVA Electoral Board Observer Corps, Kerin Yates, chair. Here is her report:

Albemarle County Electoral Board met on May 10. Discussion centered around the Republican Primary to be held in the county's small portion of the 7th district. At the time of the meeting this involved 35 voters. All rules for any election must be kept which the Board remarked is quite expensive. Software purchases and training for the primary was discussed. None of the other counties we cover or the City of Charlottesville had meetings in April or May.

LWV CVA Voter Service: Following is a list of the counties and the City of Charlottesville in regard to the June 21, 2022, Primary. Note: Voter Registration closes for this election on May 31, 2022.

Update on New York State Health Care Concurrence

On February 16th, our LWV CVA Board voted to be listed in support of the New York State Health Care Concurrence being voted on at the LWVUS Convention in June. We were the first league in Virginia. Since then, more Leagues have been added to be in support, making it 98 Leagues nationally. The Concurrence will be on the national LWV agenda for discussion and a vote.

What is the NYS Concurrence?

In 2019-2021 LWVNY did the rigorous research required to update its state health care positions. The new positions adopted in spring 2021 now provide the springboard to bring their proposals to the entire League. In Fall 2021, with help and encouragement from HCR4US, LWVNY approved moving forward with a nationwide campaign to place a concurrence with the NYS updates on the June 2022 LWVUS Convention agenda.

Why update the LWVUS Health Care Position?

The goals of the current LWVUS health care position are strong. They articulate our aspiration for health care that is

- Accessible EVERYONE is covered
- Equitable EVERYONE gets quality care
- Affordable NO ONE avoids care due to cost

LWV CVA International Relations/Federal Government Committee Meeting Report By Gerry Kruger

On May 25, 2022, the LWV CVA International Relations/Federal Government Committee held its second in-person meeting in over two years. **Lois Sandy** not only hosted, but also gave a report on Canada's health care system.

Canada's health care has been universal since 1984. Every province gets assistance from the government but has its own separate health care system. The government pays for free necessary hospital and doctor's care. Patients must pay for excluded services such as dental, outpatient drugs, and vision. Two-thirds of the population have private plans that pay for excluded services.

There are additional government agencies related to health care, such as a Food and Drug agency and Health Care Promotions.

Most insurance companies are non-profits, and doctors can't charge more than what insurance covers. However, many doctors have private practices and "closed lists," meaning they can refuse to accept some patients.

Cancer is the leading cause of death in Canada. Many have no access to therapy because of where they live.

At the end of Lois's report, **Bobbie Williams** told us of a new LWV health care committee that is now working on a policy statement. It's called the "Access to Equitable Health Care" Committee. **Stephanie Lowenhaupt** is heading the group. Anyone interested in joining this committee should contact her or Bobbie.

Our group also discussed changing our focus from health care around the world to some other issues. One of them is the gridlock that exists in the legislature at all levels of government. For the next International Relations/Federal Government meeting, we will read **David Toscano's** book, *Fighting Political Gridlock*, and discuss it. The meeting will be held in Anita Pilling's home (120 West Street, Louisa) on **Wednesday**, **June 22 at 10:00 am**. LWV CVA Child Care Committee News By Beth Kariel, Chair, LWV CVA Child Care Committee

This month Beth attended a webinar and interviewed two people.

The webinar Beth attended was titled, "Race and Education/Neurodiversity and Early Childhood Development: Supporting Children and Parents."

Beth interviewed Kate Matthew, a senior manager at the University of Virginia's Center for Advanced Study of Teaching and Learning. Beth learned about the "birth to 5" curriculum the Center developed and is now available for free to child care providers who accept subsidies. **STREAMin3**, the name of the curriculum, is one of a number of curricula identified by the Virginia Department of Education as meeting standards set by their Unified Virginia Quality Birth to Five System.

Beth also interviewed Lisa Howard, President and CEO of *Elevate Early Education*, also called E3. *Elevate Early Education* is a nonpartisan issue-advocacy organization that advocates for policy initiatives and state funds to be invested in early learning through third grade.

Lisa Howard gave Beth some suggestions for ways the League could be involved in advocacy.

"WEAR ORANGE" June 3 - 5 to honor the memories of victims of gun violence—the more than 40,000 people who are killed with guns and approximately 85,000 who are shot and wounded every year—and sadly the 10 who recently lost their lives in Buffalo, and the tragic shooting of schoolchildren and teachers in Uvalde, Texas.

"Wear Orange" event began January 21, 2013, by friends of Hadiya Pendleton. Hadiya marched in President Obama's second inaugural parade. One week later, she was shot and killed on a playground in Chicago. Soon after this tragedy, Hadiya's friends commemorated her life by wearing orange, the color hunters wear in the woods to protect themselves and others.
