What is "Program Planning"? Program Planning happens annually at the local League level. It is the time when we consider the positions taken by our League on the local and state or national levels. Our positions give the League a voice and are

the result of an established process: the LWV takes action on an issue or advocates for a cause when there is an existing League position that supports the issue or speaks to the cause. Without a position, League action/advocacy cannot be taken. This is what your League of Women Voters is all about and Program Planning is your opportunity to weigh in.

For 2022-23, we will study **Local** and **State League positions** in preparation for our May 2023 *LWV CVA Annual Meeting* as well as the June 3-4 LWV-VA convention. Do we wish

- to retain current positions;
- to act on them; and/or
- begin new studies with the goal of establishing consensus and positions for action on other issues?

To prepare for our 2022 meeting, check out our Local Program: Positioned for Action as described in the LWV CVA 2022-2023 Member Handbook [yellow cover]. On pages 16-21, you will find "Action" items on: Government, Natural Resources, and Social Policy. (These positions can also be found on our website: <a href="https://www.cva.org">www.cva.org</a> under the pull-down menu, "Explore the League" – Advocacy, then click on "Local.") LWV CVA Vice-President Carol Cutler recommends that you read the Program section (pages 16-21) of the LWV CVA 2022-23 Member Handbook before you come to the meeting.

Similarly, review the **LWV-VA** state positions on **Government** (current study: Campaign Finance Reform): Delegation of Power, Election Laws, Fiscal Policy, Reapportionment and Redistricting, Transportation, Women's Rights in Virginia Law; **Natural Resources** (current study: Environmental Justice) Air Quality, Extractive Industries: Hydraulic Fracturing, Land Use, Water Supply and Distribution; and **Social Policy** (current studies: Child Care, Education Equity) Adult Domestic Violence, Adult Justice, Affordable Housing, Child Care, Children at Risk, Education, Juvenile Justice, Behavioral Health, [Civil] Rights of Felons in Virginia, Offender Re-entry. These positions can be found on the <a href="https://www.va.org">hwv-va.org</a> website by clicking on the drop-down menu "Positions and Advocacy." Carolyn Caywood, LWV-VA Program Planning director, asks us to consider "how each position has, or has not, aided advocacy in the last two years. What has changed since the position was approved and is the position broad enough to cover the new circumstances?" Two goals to keep in mind: this is how we keep our positions up-to-date and member-driven, and afterward members should be more familiar with the positions. We will send in our responses by Feb 28, 2023.



Action: Monitor and take action to support efforts to improve access to affordable, quality health care and health equity in the Charlottesville area under the LWVUS position on health care reform, with a particular focus on disparities affecting vulnerable populations; partner with other local organizations and coalitions to identify needs and develop strategies to address them.

### From Stephanie Lowenhaupt: "Protect Our Democracy Day"

Students from the University of Virginia and Community Members gathered on October 22to listen to speakers and have a conversation regarding threats to our democracy. Featured speakers included Sally Hudson (Virginia House of Delegates District 57), Erik Curren (Living Historian), William Hitchcock (History Professor at UVa) and David Pepper (author of "Laboratories of Autocracy"). All spoke about threats to our democracy currently and from a historic perspective. The main action people can take is to go vote. Democracy is not a spectator's sport. After the panel discussion, there was time for all attendees to share their thoughts about democracy in today's world and ways to engage student as well as local groups in a coordinated manner to work toward protecting our democracy. Our local League was a sponsor of this event. There was an opportunity to engage with participants to tell them about our local League. Some students and community members were not aware of what we do so it was a great time to let them know.

### LWV CVA International Relations/Federal Government News By Gerry Kruger

Prior to the October 19, 2022, International Relations/Federal Government Committee meeting, Rice Wagner emailed our members an article from the Economist entitled "The Disunited States." It concerned the federal gridlock resulting from the courts giving the states more power to make their own laws regarding abortion, immigration, gun control, education, and voting rights. The article stated that partisanship and the culture war issues seem more important to many politicians and voters today than fair representation. Because 37 of 50 states have one party control in the House, Senate, and Governor, there is less incentive to compromise, more entrenchment, extremism, and divergence of views. Led by Anita Pilling, our members discussed some of these issues in conjunction with the final three chapters of David Toscano's book, *Fighting Political Gridlock*, at our meeting in the home of Lois Sandy. Abortion, guns, and immigration generated some of the following comments:

### **ABORTION**

- Less than 1% of abortions occur after 20 weeks, but this has become a contentious issue in the US.
- 13 states have banned abortion since the Supreme Court reversed the Roe decision.
- Some medical procedures done for a variety of gynecological issues would now in many cases be considered an abortion with negative consequences.
- Abortions done without medical care can have serious consequences for the woman and her family.
- Imposing religious definitions of when life begins is a separation of church and state issue.
- Some political candidates and voters blindly adhere to abortion as if it were the only basis for choosing a candidate in the next election. Vega vs. Spanberger in the 7th District is an example of this.

### **GUN VIOLENCE**

• It's more acceptable and less contentious to discuss guns in terms of gun

- safety rather than gun control.
- Virginia has red flag laws but in resistance to this measure some communities have designated themselves "gun sanctuaries."
- Lowering the age to obtain guns is problematic because neuroscience has shown that the human brain doesn't develop fully until age 21; thus, the capacity to discern consequences of actions may not be in place.
- 23 states now have open carry which increases the danger of guns being used if disagreements arise.
- Some groups are giving away free gun locks.
- It's important to ask candidates what their stance is on this issue.
