The League of Women Voters of the Charlottesville Area, along with Sierra Club Piedmont Group and Piedmont Environmental Council, are co-sponsoring an "online interactive discussion" to solicit your feedback regarding the Comprehensive Plan for Albemarle County. The Comprehensive Plan is a guiding document for growth, development, and investment in the county. The plan is being updated because it is required by the state and it's a way to respond to the changing needs of our community.

An ongoing program, the Albemarle County 2044 Comprehensive Plan update (AC44), began in 2022. This event is part of the AC44 Phase 2 Comp Plan update. The AC44 process is a chance to enhance the quality of life for all members of the Albemarle County community, including residents, workers, and visitors, so that everyone may benefit. This event provides a platform for individuals to share their opinions, perspectives, and knowledge. Feedback from meeting attendees as to what they envision for the next 20 years will be sent to County

staff.

Saturday Welcome Speaker is Provost Peggy Agouris, Chief Academic Officer, William and Mary University. Brenda Andrews, President and Owner at New Journal and Guide Newspaper – Virginia's oldest Black weekly newspaper – is the Saturday lunch speaker.

Professor A.E. Dick Howard, the Warner-Booker Distinguished Professor of International Law at the University of Virginia, is our Special Saturday Banquet Speaker. Prof. Howard rewrote the Virginia Constitution in 1971 to guarantee

Black voting rights and was a chief consultant to Governor Terry McAuliffe's efforts to restore rights to returning citizens. He is widely acknowledged as an expert in the fields of constitutional law, comparative constitutionalism, and the Supreme Court.

International Relations/Federal Government Meeting Report By Gerry Kruger and Rice Wagner

The International Relations/Federal Government Committee met at Northside Library on March 16, 2023, with Chair Rice Wagner. Carol Cutler, Kathy Sudduth,

Jean Minehart, and Gerry Kruger attended.

We discussed meeting at the Northside Library for the next three months: April 20, May 25, and June 15. These meetings will continue to take place at noon. Members are invited to bring lunch if interested.

Carol Cutler's presentation focused on the "17 Sustainable UN Development Goals." The League has a long history of strongly supporting both the United Nations and the importance of nations working together to promote world peace, security, human rights, the environment, and the full participation of women in civil and political life. (*Impact on Issues*, 2022-2024)

Before our meeting Rice sent us an attachment with the 17 goals that the UN adopted on September 25, 2015. The 17 topics are:

- 1. No Poverty
- 2. Zero Hunger
- 3. Good Health and Well-being
- 4. Quality Education
- 5. Gender Equality
- 6. Clean Water and Sanitation
- 7. Affordable and Clean Energy
- 8. Decent Work and Economic Growth
- 9. Industry, Innovation, and Infrastructure
- 10. Reduced Inequalities
- 11. Sustainable Cities and Communities
- 12. Responsible Consumption and Production
- 13. Climate Action
- 14. Life Below Water
- 15. Life on Land
- 16. Peace, Justice and Strong Institutions
- 17. Partnerships for the Goals

Our group discussed the importance of population control, legislation, and raising awareness in accomplishing the goals. For example, our League's Gun Violence Prevention committee has worked to raise awareness in our community and state by participating in rallies, attending lobby day at the state capitol, and distributing copies of safe gun owner practices for businesses to display.

Many of our committees have prepared programs for community dialogues and seminars that tie into the UN's goals.

Impact on Issues states, "...before the UN was established, the League ...to help build understanding of the Dumbarton Oaks and Breton Woods agreements to

establish the UN, the World Bank, and the IMF, trained more than 5,000 speakers and distributed more than a million brochures during a six-month period."

The League can do much today to raise awareness about the importance of working together toward these goals.

Some questions to consider:

Are students taught about the UN today?

What organization could take the place of the UN?

Who is our current representative to the UN? (Linda Thomas-Greenfield)

Are there any pending laws on the national level that support the UN goals?

Would there be a new definition of 'gender equality'?

What is the UN currently doing?

What % of funding does the US now provide?

Are we as a capitalist society providing for the lowest socio-economic level?

What are the precise definitions of democracy and socialism?

How can we adapt the LWV national position to the local LWV?

Is the US willing to continue with a long-term commitment, both pre- and post-conflict (ex. Ukraine)?

We discussed the arrival of Liz Cheney to UVA. All seemed positive about her contribution, both in the past and the future. Meg will keep us informed on her public appearances. We look forward to seeing our LWV members at the next meeting—April 20 at noon in the Northside Library. We will continue discussing Impacts on Issues—League History, pp. 69 on. All are welcome!
