LWV CVA Voter Services Update

On February 17, 2023 the Virginia Senate passed <u>HB1948</u> (Bloxom). The House passed the bill unanimously on February 2. **Beginning July 1, 2023, absentee** ballots will no longer require the verification of a witness. Instead, voters will be required to provide the last four digits of their social security number along with their date of birth and signature. <u>Please note, however, the witness signature</u> will still be required in the June primaries.

During the pandemic, the League of Women Voters of Virginia (LWV-VA) partnered with ACLU-VA to bring legal action to waive the witness requirement for absentee ballots. While voters had relief during the state of emergency, the requirement was reinstated once the declaration expired. **LWV-VA President Deb Wake** expressed, "We appreciate the bipartisan support of lawmakers who worked to permanently remove this barrier so that voters wishing to cast an absentee ballot are able to do so without extra hurdles. We especially appreciate Delegate Bloxom's attention to this issue."

"When we successfully went to court in 2020 to waive the requirement, the result was more Virginians being able to vote — and no fraud," said Vishal Agraharker, senior staff attorney for the ACLU-VA. "We look forward to the Governor signing this bill into law."

The League supports allowing voters many options for exercising their right to vote. In the 2022 General Election, 2,044,714 voters voted on Election Day; 666,677 voted early; 296,731 cast their ballots by mail and 14,477 accessed the ballot via the curbside option. Having options increases opportunities for voter participation.

LWV CVA Gun Violence Prevention Committee Report

The following is an update from Andy Goddard, who tracks GVP legislation in the Virginia General Assembly:

Great day [Feb 20] in the Senate Judiciary meeting! Of the 8 bills we opposed, 6 were Passed By Indefinitely (PBI) by votes of 9-6. These included:

HB 1407 exemption for CHP (concealed handgun permit) holders from prohibition on carry in Capitol Square and government buildings etc.

HB 1462 removing the 30 day waiting period and allowing people with brand new Virginia driver licenses to purchase firearms immediately. (This was put in place to prevent people from coming to VA, getting a driving license and then purchasing handguns as a "state resident" then leaving VA and selling the guns - straw purchases).

HB 1570 exempting highway rest areas from the ban on carrying of firearms and explosives.

HB 2228 allowing renewal of CHP without need for proof of prior training or competency.

HB 2420 creating a default proceed after 90 days for issuance of a nonresident concealed handgun permit.

HB 2460 allowing certain state employees to have firearms in their vehicles parked on state property.

TWO bills were reported, the first was the bill HB2467 which allowed certain individuals who did not allow their photograph to be taken (for religious reasons) to purchase firearms using a special "VA drivers" that has no photo. The bill would only allow the purchase to be from a private seller at a gun show where State Police would be present to perform a background check. This is a very limited situation. However, Lori pointed out that the Federal form needed for such a transaction specifies that the ID must have a photo. Therefore, even if this bill passes to the Governor, State Police would NOT be able to comply with it unless Federal Law was changed.

Finally, switchblade knives! Last year the manufacture and sale of these

knives was legalized and this year HB 2298 would have removed switchblades from the law against carrying concealed weapons. I have repeatedly pointed out that the term "switchblade" is too broad and covers both relatively harmless utility knives as well as knives designed entirely as weapons, with no practical utility except as stabbing weapons. I repeated my testimony, but this time the committee listened and Sen. McClellan moved an amendment to change the bill from removing "switchblades" to instead keeping the prohibition against concealed carry of "stiletto" knives! The bill as amended then passed 12-0.

All in all a VERY good day in the Senate.

LWV CVA Health Care Committee Report By Stephanie Lowenhaupt, Health Care Committee chair

The Health Care Committee has been following Virginia legislation specific to health care equity and access in line with the LWV national position.

"Cover All Kids" (SB1327) would have established a program to provide state-funded comprehensive health care coverage for individuals in the Commonwealth who (i) are under 19 years of age, (ii) are not covered under a group health plan or health insurance coverage, and (iii) but for their immigration status would be eligible for Medicaid. The bill passed the Senate with a vote of 24 Yes and 16 No. Unfortunately, the bill was killed in the Health Welfare and Institutions Committee on a party line vote. Funding for the program is included in the Senate budget, so there is still the opportunity for the program to be included in the compromise budget.

Other legislation we followed included budget amendments by Senator Deeds and Delegate Sickles to streamline Medicaid enrollment for SSI recipients. They were not included in the Senate or House budgets.

HB 1375 eliminates the authority of a health insurance carrier to vary its premium rates based on tobacco use. Under current law, a health carrier may charge premium rates up to 1.5 times higher for a tobacco user than for a nonuser. The bill has passed the House and Senate. The bill is awaiting the Governor's signature.

After the legislative session, we plan to focus our work on access to transportation for medical care in our service area. The prevailing needs to access care that have been identified as most acute are bus routes and shelters, handicap access, ride sharing access, and increasing JAUNT routes to outlying areas.

International Relations/Federal Government Meeting ReportBy Gerry Kruger

On Thursday, February 16, the LWV CVA International/Federal Government Committee met at Northside Library. Carol Cutler and Susan Roberts filled in for Rice Wagner, our Chair. Also attending were Gerry Kruger, Elaine Longerbeam, Jean Minehart, Bobbie Williams, Katie Angioletti, and Kerin Yates.

Susan Roberts opened the meeting by going through the International Relations section in **2020-22 LWV** "Impact on Issues." We were most interested in studying global issues of governments other than the United States. Carol Cutler agreed to present a report on the "17 Sustainable Goals to Transform Our World" at our March meeting.

Next, we continued our discussion of the Washington Post article entitled "Leaders of Democracies Increasingly Echo Putin in Authoritarian Tilt." We considered the different ideologies of Democrats and Republicans and the concerns that they

may have in common. We think Ukraine and immigration could be two things both parties could work on together. The article we discussed said three things authoritarian leaders have in common are populism, polarization, and post-truth. We discussed social media's role in spreading all of these. We contemplated possible consequences for an ex-President who is found guilty of a crime. Most of us felt he should never again hold any government office rather than being sent to jail.

Other conclusions we came to:

- 1. Supreme Court Justices should be held accountable by an ethics unit. If they fail to follow acceptable standards, there should be consequences.
- 2. Some judges whom President Trump appointed refused to side with him. This proves there are judges that take their oaths seriously and don't allow partisanship to override the Constitution.
- 3. The more informed and educated the electorate, the better leaders we will have. This underscores the primary mission of the League.
- 4. All elected officials should be vetted and required to turn over tax returns.

We invite members to join us on the third Thursday of each month as we meet at Northside Library at noon. Our next meeting will be held on March 16.

In Memoriam: Lois Rochester

1928 - 2023

Sadly, we share the announcement of the passing of Lois Rochester, LWV CVA past president (1986-88). Lois along with her husband Dudley of 73 years was a devoted League member. She not only served as president of our local League back in the 1980's, but she also served on the board of the League of Women Voters of Virginia as Vice-President for Organization and Chair of State Financing of Education. In 1986 Lois was appointed to Virginia Governor Robb's Commission on the Future of Virginia and, later, to Governor Baliles' Commission on "Excellence in Education." She was also active in the FOCUS Women's Resource Center and served on the board of the Funeral Information Society of the Piedmont (FISP). A service honoring her memory was held in Westminster-Canterbury of the Blue Ridge on Saturday, February 18, 2023.
