"Healthy Streets, Healthy People" Community Wide Event held on July 8

On July 8th our local league participated in a community wide event, *Healthy Streets Healthy People*. A free family-friendly event that focused on improving safety and environmental health in the Charlottesville area. There was an opportunity to learn how attendees could help make Charlottesville a healthier place to live. The event was hosted by Well AWARE (Neighborhood Healthcare Advocates) and Move2HealthEquity.

There were over 40 exhibitors such as UVA Health, Blue Ridge Health District, Emergency Medical Services, Free Clinic, Local Food Pantries, Moms Demand Action, Piedmont Environmental Council. The League was one of the exhibitors providing information about gun safety, giving out gun safety locks and did a raffle for a biometric gun safe. In addition, we did voter registration and recruited two new members.

Electoral Board Observers Corps

The *LWV CVA Electoral Board Observers Corps* with Kerin Yates, chair, observes and reports on electoral board meetings in our League area. Kerin Yates covers Albemarle County; Lisa Hilgartner - Nelson County; Sue Lewis - City of Charlottesville; and Karen Davenport - Louisa County.

In general, the discussions/actions of the May, June, July meetings of the electoral boards we observe can be summed up as (1) covering resources, (2) training, and (3) planning. Louisa used a new opportunity for the June primary: summer interns. Louisa's EB provided basic induction prior to accompanying Electoral Board members on their appointed rounds on primary day. Other notes from the various Board meetings include:

- Albemarle's Electoral Board handled 129 provisional ballots from the June 20 primary. Review took about four hours. Only two were rejected. Charlottesville processed 79 provisional ballots for the June Primary and approved 74 of them.
- Reappointed as General Registrar and Director of Elections for four years (7/1/23 to 6/30/27) are Albemarle: Lauren Eddy; Greene: Jennifer Lewis-Fowler
- The Charlottesville Electoral Board will present a report to Charlottesville City Council on August 21 on implementing Ranked Choice Voting in the city.

League members are reminded that the electoral boards do not create policy. Their task is to implement policy created by the state. The LWV CVA Corps welcomes Carol Cutler who has volunteered to cover Fluvanna. We would welcome a member to volunteer to cover Greene. You do not have to live in the county to do that.
