IR FG News By Gerry Kruger

The International/Relations Federal Government Committee met at Northside Library on March 27, 2024 with Chair Rice Wagner presiding. Attending were Carol Cutler, Miriam Fleitman, Gerry Kruger, Jean Minehart, Anita Pilling, Diane Skalak, Kathy Sudduth, and Bobbie Williams. The focus of our meeting was the 2024 Viirginia General Assembly session and Governor Glen Youngkin's vetoes and amendments. Anita Pilling began our discussion with Youngkin's push for a sports arena at Potomac Yard in Alexandria. Sen. Tim Kaine opposes it because Virginia taxpayers would be responsible for paying off the bond necessary to pay for it. If there is an emergency and the bond must be paid off, our taxpayers would have to foot the bill. Also residents in the area are strongly opposed. The traffic problems it would cause are another concern. Still, Youngkin insists that he will continue to promote it. It would create jobs and could make a great deal of money for those who invest in it, not for our state. Democrats control the Senate with 21 members while the Republicans have 19. In the House of Delegates, there are 51 Democrats and 49 Republicans. As of March 24, Governor Youngkin has vetoed 70 bills and returned two to the Assembly for amendments which he suggested. One of the two amendments concerns parents' legal responsibilities to keep their children safe with firearms in their homes. He questions how this could be carried out effectively. The other amendment involves a religious exemption to a bill requiring health insurers to cover birth control. The governor must give a written explanation of each bill he vetoes. His vetoes chiefly concern highly charged partisan issues. Following is a list of issues included in many of them:

Firearm safety and sales Voting and voting rights Immigrants Sexually explicit materials in schools Library books with sexually explicit content Incarceration alternatives Train safety Police official requirements Minimum wages

Some of the bills the governor signed into law concern same-sex marriage, preferential university admissions, and prosecuting violations of protective orders.

The next meeting of the International Relations/Federal Government Committee will be held again at Northside Library on April 18 from 1:00-3:00 pm. It will feature Putin's Russia. We invite you to join us for informative, lively discussions of issues important to voters.

Natural Resources Committee News by Linda Goodling

Comprehensive Plans are a topic appearing in local newspapers recently. Your Natural Resources committee for many years has worked on providing our local governments some guidance (based on League principals and adopted positions). We've also trained members to take part, sometimes being so successful that our members sit on the Planning Commissions and governing bodies. In the last couple of years, while it's become easier to watch local government via transmissions in the comfort of your own home, the League has appeared less often — a rather ironic effect of improved listening opportunities. Our League did speak up last month, and you still can participate as the Comprehensive plans are being updated.

Virginia requires local governments to have a plan that looks out 20 years, and is updated every 5 years. (The 20-year requirement explains "AC44" as the name for Albemarle County's updating process this year.) A Comprehensive Plan is the necessary underpinning for a local government's land-use planning and decisions like zoning, growth management, traffic patterns, adequate water and sewer treatment, and all manner of projects, both by government and private individuals. In the hands of autocratic government, that can trample individual rights, as you can imagine. What protects Americans is insisting that Plans have to have citizen involvement during drafting, revising and adopting — that's where the League and you come in. We have to take part or

there is no true citizen involvement.

Last month, we made a formal comment to the County Planning Commission and Board of Supervisors in a letter signed by our president, Meg Heubeck. In it, we recognized the importance of the Comprehensive Plan in protecting the unique landscape of Albemarle County and maintaining a high quality of life for all in the face of climate change, population growth and biodiversity loss. We asked that the County continue its policy of protecting the rural area from sprawl, so that the important resources we depend upon—our freshwater, forests and agricultural land-- can continue to provide for us into the future.

We endorsed our County's commitment to mitigating climate change by incorporating the County's Climate Action Plan throughout AC44 and improving our resiliency to increased risks of flood, drought and wildfire.

And last but not least, we promised that we would be watching closely as AC44 continues to take shape over the next several months.

Charlottesville has adopted its newest version and has created a very new zoning map based on it. Albemarle's Plans, goals and central policies (such as how far into the countryside we'll have suburban growth) are being discussed and decided, with some decisions already. But many decisions remain, especially how to implement the policies in the Plan.

The best way to participate is to join the Natural Resource committee! But on your own, there are many ways to be engaged. Writing the Board of Supervisors (BOS@Albemarle.org) (FluvannaCounty.org) or Planning Commission (PlanningCommission@Albemarle.org) can be worthwhile; attending meetings is surprisingly interesting and being seen in the audience is an effective reminder to officials that citizens are watching. Each website has extensive information on topics and agendas.
