Committee News

International Relations and Foreign Government News By Gerry Kruger

The International Relations/Federal Government Committee met on Wednesday, May 29 at Northside Library. Attending were Chair Rice Wagner, Anita Piling, Gerry Kruger, Jean Minehart, Lois Sandy, Carol Cutler, Kathy Sudduth, and Diane Skalak.

Anita Pilling and **RiceWagner** have highly recommended two books for members of our chapter to read:

1. *Keaaing the Constitution: why I Chose Pragmatism, Not Textualism* by Stephen Breyer (Justice Breyer shows a better way to interpret the Constitution.)

2. Creature from Jekyll Island: A Second Look at the Federal Reserve by G. Edward Griffin

Anita Pilling again led our discussion of Vladimir Putin's Russia and the danger he presents. Anita is a friend of a Russian born woman named Tatianna, who left Russia in 2010 due to the economic situation there. She now lives in Louisa and is married to a Ukrainian man. Tatianna has verified Anita's notes about Putin's dangerous activities, even though she once was a Putin supporter.

After his first two terms as President, Putin's actions showed his increasingly aggressive and violent ways: his use of mercenaries in Africa to cause a civil war and extract mineral wealth; his violent suppression of Chechnya and Georgia separatist movements; his invasion of Crimea when protestors ousted the Putin-backed President; and his slaughter of hundreds of thousands in his all-out war against Ukraine.

Not helping Ukraine win the war would send a signal to our enemies that the US and the West will forsake our allies. This would encourage more attacks on Moldova and the Baltics. As Putin continues to fight this war, his dependence on China for technology and weapons increases, and the people suffer under a brutal totalitarian regime. A victorious Russian army could leave Putin commanding a superior fighting force with 21st century warfare skills and armed with thousands of nuclear warheads.

In the March 2024 election, there was no opposition and no scrutiny. Putin won with 87% of the vote. His power rests on systematic repression, violence, lies, and corruption. His wars have also put a strain on the economy. As the Russian economy wanes, so does its population. More and more Russians are escaping from the country, and fewer Russians are having babies. This hurts the economy even more.

Putin spreads misinformation about NATO, Nazis in Ukraine, and the West's decadent social norms. Also hobbling global institutions such as the UN Security Council makes Russia a threat to the liberal world order.

But the West can defeat Putin by promoting universal liberal values, countering Russian misinformation, and welcoming Russians who wish to leave their country. We should also ensure there are humanitarian exceptions to sanctions, such as medical supplies and educational materials. Financing Ukraine's struggle is cost effective for the United States. Helping Ukraine keeps us from having to fight, which would result in huge losses in money and lives. If we provide ammunition and weapons for their cause, this also provides jobs for our people.

During our June meeting, several committee members will lead our discussion on important aspects of Project 25, the conservative plan for the Presidential Transition. The date and time of our June meeting has not been set because Northside Library has reserved the third Wednesdays for another group. We hope to arrange another day soon. Stay tuned.
