## International Relations and Federal Government Committee Presents:

Consensus Meeting on Study by LWVUS on Ethics in the Federal Judicial System
Saturday, March 15th, from 1-4 pm
Northside Library, Charlottesville

Please make it a point to get involved in this important work!

At the 2024 LWVUS Convention, in June, approval was given for a fast-track study of the US Federal Judiciary as an essential component of US democracy. The goal is to adopt a position at the 2025 LWVUS Council in June that outlines the values – the standards and norms – the League of Women Voters should use in evaluating proposed changes to policies, laws, and regulations about the federal judiciary. The study's purpose includes, but is not limited to, addressing concerns, and clarifying judicial accountability, transparency, independence, and ethics.

Now this study is complete. Anita Pilling, along with members of her committee, will conduct this consensus meeting. At this meeting the

background and findings of this study will be discussed and questions related to the study will be addressed. Once concluded the information gathered will be sent to our LWVVA coordinator who will in turn send them on to LWVUS.

# Ranked Choice Voting is Coming to Charlottesville

Big changes are coming to the City of Charlottesville's elections! This June, for the first time ever, voters will use ranked choice voting to select candidates in the City Council primary. The League of Women Voters, in partnership with Ranked Choice Virginia, is offering several opportunities to learn more about this new method of voting.

In a ranked choice election, voters can rank all the candidates from most to least favorite: first choice, second choice, and so on. The ballots are then tallied in an instant runoff to find the top two winners with the most support from all the voters. If your favorite candidate doesn't win, you can still help pick the winner with your backup choices, ensuring that more voters get a meaningful say in choosing their representation.

The voting public is invited to join any of three educational sessions to learn how ranked choice voting works, why it is used, and how it finds roots in Charlottesville's long-running history of democracy reform. The sessions are free and will last one hour, with time for discussion.

#### Natural Resources Committee by Peggy Gilges

The NRC continues to follow the evolution of Albemarle County's new comprehensive plan, AC44. Last year, the LWVCA submitted comments encouraging the Board of Supervisors (BOS) to maintain the County's existing growth area boundary and protect more of the rural area through conservation, because the benefits are many.

While the Albemarle BOS had previously declared their intention to prevent sprawl by limiting suburban residential and commercial growth to the existing designated growth areas (Development Areas), AC44 discussions have been continuing, and new edits to the AC44 draft keep cropping up. At a work session held on February 19, the BOS considered **several new proposals to expand growth**. Among these are: a proposal to swap land from the development areas with land in the Rural Area, a proposal to allow transfer of development rights ("TDRs") from parcels that include important natural resources in the Rural Area to parcels proximate the Development Areas in the Rural Area, a proposal to allow restaurants at farm wineries and farm breweries in the Rural Area, and two proposals for studying infilling development at I-64 interchange areas on US 250 west of the Yancey Mills interchange near Crozet and US 250 east of the Shadwell interchange. We are concerned that these proposals will encourage sprawl and new development in the Rural Area of the County that we have long protected.

The BOS has also thus far failed to commit to reviving its mothballed

conservation program, the Acquisition of Conservation Easements ("ACE") program. Under the ACE program, the development rights of land that meets specific criteria for preservation (such as forest blocks, biodiversity and habitat value, riparian and wetland ecosystems, agricultural soils) may be purchased from landowners by the County. The ACE program makes it possible for lower-income rural landowners whose land is most at risk of sale for development to conserve their land. In general, counties benefit from conservation easements because they ensure land is protected and will continue to serve residents through a myriad of vital ecosystem services such as climate change resilience, carbon dioxide sequestration, promoting water quality and quantity, food production capability and biodiversity protection. In addition, conservation easements provide economic and fiscal benefits to County residents by supporting the local economy through tourism of protected historic and scenic sites, increasing the amount of school funding received from the state through the Local Composite Index, and not adding to the growing cost of community services (sewer/water, fire/rescue, roads) that are required for commercial and residential areas. In Albemarle's case, conservation easements also reduce the amount of payment made annually to Charlottesville through the longstanding revenue sharing agreement.

The NRC urges its members to stand up for our natural resources both to protect our wellbeing and quality of life now, and also as a matter of our responsibility to future generations. As AC44 continues to develop, League members in Albemarle are encouraged to closely watch any changes to the County's established growth boundary policies and to voice support for Albemarle's ACE program and the Albemarle County Easement Authority (ACEA). Given the pressures of climate change, population growth and economic development in Albemarle and surrounding counties, policies to prevent sprawl and protect natural resources are more important than ever.
